## Residential Development (1 & 2 Family Dwellings)

Major – final plat	\$50 Hearing + \$125 / lot + Recording fee as set by the State of Vermont (\$10)
Mylar (applies to all subdivisions)	Per sheet: Recording fee as set by the State of Vermont

Application and hearing fees are due at the time of application. Applications that require multiple hearings need only pay the fees for the next hearing. Scheduling of the next hearing will require that the fees are paid for that hearing, and that any required additional information has been submitted to the Planning Department. Zoning Permits will not be issued until all improvement, change of use, new lot fees, etc. are paid.

Application fees are not refundable. Hearing fees are not refundable after the Notice of Hearing has been submitted to the Reformer. No fees are refundable after the permit has been issued. Requests for reimbursement must be submitted in writing. Reimbursement will take approximately 30 days.

For Development Review Board applications, 12 copies of each form and diagram (except for Form P) plus the original are to be submitted. Applicants are encouraged to make their own copies to avoid the above listed copy charges.
