January 21, 2020 Selectboard Meeting

***SPECIAL EVENT PERMIT*** – *Allows manufacturers of spirits, malt or vinous beverages to sell by the glass or by unopened bottle. May offer samplings for the purpose of tasting only, but no more than two ounces per product and eight ounces total of malt or vinous beverages and no more than one ounce in total of spirits to each individual.*

On Thursday evening, February 6, from 5:00 to 10:00 pm, a group of downtown merchants, headed up by Stephanie Bonin from the Downtown Brattleboro Alliance, will host the Brattleboro Luv Crawl. The event pairs Vermont brewers and distillers with area merchants who have agreed to keep their doors open to shoppers during that evening.

Alcohol dispensing in each store will be set up in compliance with Vermont Department of Liquor Control regulations.
