




COVID-19

During this month, Public Works has continued to fight the spread of COVID-19. We have instructed staff to perform all essential tasks while working as separately as possible. As we watch the number of new cases in Vermont plateau a bit, we're confident knowing that we're doing our part to stop the spread and lessen the curve.

Highway Division

This month, the crew began shifting away from routine summer work and transitioned into fall operations. They have been actively cleaning out the drainage ditches on the gravel roads and doing our final grading. Preparation for the new salt shed has begun and staff is assisting in that project. In addition to these routine operations, the first project in the annual capital paving project was completed including the Police Department parking lot, the Preston lot, Chestnut Hill and Acorn Lane. The highway crew also completed our annual fall line striping (crosswalks and stop bars).

In addition, the crew performed routine seasonal operations such as brush removal and roadside mowing. The crew also tended to the gravel roads, grading and raking.

Maintenance Division

This month, the maintenance division has been focused on getting our equipment ready for winter. Staff has been doing repair work on vehicles from the Fire Department and the Recreation & Parks Department as well as plant maintenance at the DPW facility. In addition to general maintenance of the fleet, the staff has been mowing the lawn at the Fairground Rd facility and working on general building/grounds maintenance.

Distribution & Storage

This month, the Distribution and Storage crew has worked to prepare the manholes and valves for paving projects. They also completed our quarterly meter reading along with change outs and call backs. Crews repaired a water line on Goldfinch Lane. Fall water main flushing began at the end of the month and will continue through the first part of October. Distribution and Storage crew has also been performing routine operations such as hydrant maintenance, vehicle maintenance, and various service calls.

Water Treatment

Water Treatment staff have been working on watershed maintenance and repairs to Pipeline Road. Staff tests the water daily and are under contract to operate the Welcome Center and the Algiers water system. They continue to do all the daily maintenance of the all the water facilities and patrol the watershed. Staff has been maintaining required certification requirements by attending courses and classes on water treatment.

Wastewater Treatment

Wastewater Treatment staff continues to perform routine Plant and pump station operations. They continue to complete all statutory testing as required by our licensure by both State and Federal agencies. The Plant continues to operate in compliance with all permitting requirements.

Summary of Major Activities/Work Projects:

- 1. General COVID-19 Operations** – Due to the COVID-19 pandemic, beginning March 26 all of our staff began working remotely. One staff member had been going into the office when the mail is available to process document requests, dog licenses and land recording. We have still been available to the public by phone and email to answer any questions and help in every possible way. We continue to process voter registrations online, and are catching up on many data entry and cemetery mapping and indexing projects. Our team is staying busy and being as creative as we can to continue to serve the public. Along with the rest of the Town offices, we began our Phase-I soft opening to the public on May 4, in accordance with the procedure put out by the Town Manager's office. At least one staff member has been in the office daily from 8:30am to 5pm, with appropriate breaks. With the upcoming elections, we have been functioning at full capacity in the office, including volunteers daily.
- 2. Representative Town Meeting** – Due to COVID-19, RTM was held on September 12 through Zoom. It was a long meeting, but we had no major technical issues.
- 3. November General Election** – Preparation for the General election is well under way. Ballots were mailed to all active registered voters by the Secretary of State's office in mid-September, and we have received quite a number back already. Additionally, ballots are being mailed out by the Clerk's office to anyone with a change of address or a newly registered voter. The BCA has laid out a plan for a social distance floorplan at the American Legion. All voters are encouraged to return their ballots using the drop box in the Municipal Center parking lot, or bring them directly to the polls on November 3.
- 4. Board of Civil Authority** – The Board will meet on October 21 for a pre-election meeting, and again in the final week of October for an election worker training.
- 5. Board of Abatements** - The Board will meet again on October 21 to hear four abatement requests.
- 6. Liquor Licenses** – As of July 1, 2019, we are now processing and approving 3rd class liquor licenses locally along with the 1st and 2nd class license renewals before sending them to DLC for final approval. Additionally, Brattleboro currently has three businesses that hold seasonal 3rd class licenses, and we will be seeing their applications for approval on October 6, in addition to in February.
- 7. Vitals and Land Records** – we are processing these as we are able through mail, email and online payments. We continue to encourage the public to request documents through email, mail, and fax.
- 8.** As time allows, work continues on computerizing cemetery records, digitizing land records and other older town records.
- 9.** Day to day operations continue to operate smoothly.

Summary of Major Activities/Projects/Communications

- After several decades of emergency response within Brattleboro and to the surrounding community, I am sorry to say that the service of the Dive Team was suspended indefinitely as of Saturday, October 3. This will not affect any other water related rescue operation.
- Two members of BFD are taking a *Pumper Apparatus Driver Operator (PADO)* course being held in Putney. The class is held 2 and sometimes three days a week and runs through October.
- Thirteen members are enrolled in a Conflict Management class being held at BFD on October 14. This class is being taught by VTC.
- The new building on South Main St for Groundworks is all but framed in and is getting regular inspections from BFD and VT Division of Fire Safety.
- Budget preparation for FY22 has begun
- Due to COVID our fire prevention program deliveries have been limited for the past several months. Because of this we have recently been filming short fire prevention messages and will be posting them on our social media platforms. We are also doing this during fire prevention week as a way to reach out to the schools.
- AC Howard has spent a lot of time doing occupancy numbers for different businesses as they try to adjust to COVID guidance
- The duty shift was downtown during Gallery Walk on October 2 to hand out more masks and fire prevention material.
- We have again been offered 2 buildings at Melrose Terrace for training evolutions before they are demolished. Asbestos abatement is now taking place and they should be ready for use either the week of the 12th or 19th. This type of an opportunity is rare and very much appreciated as it gives us a chance to provide realistic, yet safe training evolutions. Thank you Brattleboro Housing Partnership!

Update on Vernon

- With the temporary suspension of services of the Vernon Fire Department BFD has played a major role in providing emergency services to the town. Along with Guilford and Bernardston, we have each taken a part of the town to cover and C1 will sit on the advisory board as the Selectboard begins the process of rebuilding the membership. BFD has also been asked to take a lead in the training to help them get back on their feet. We all look forward to the next chapter of the VFD.
- BFD has responded to 2 calls in Vernon since the closure, a cardiac arrest and a motor vehicle accident.
- Vernon First Response (EMS) will again be providing service beginning on Thursday, October 8.

Budget Concerns/Impacts

- Due to long term recovery injuries, FMLA leave for babies, and vacancy and a surgery we have been working pretty short staffed and filling a lot of shift to meet minimum staffing. This has used up more than a normal amount of overtime in this short of a period.
- We have been plagued with a few serious vehicle mechanical issues which has hit the vehicle maintenance line.

Staff news

- I am very pleased to announce that Mesa Kennedy has been hired to fill the firefighter vacancy. Mesa has served for 3 years on the Call Staff and she performed extremely well during the testing process. She will begin her 40 hour orientation on October 13 (4 ten hour days) and her first day on shift will be October 18, assigned to Platoon 3. Mesa lives in Brattleboro, is the 2nd female on the Career Staff, and the 1st since 2003. Welcome Mesa!

Summary of Major Activities/Work Projects:

Skatepark Project:

Parker Construction with DMI have wrapped up the Skatepark Project. We had a grand opening celebration on Oct 3RD and had over 100 people in attendance. On a daily basis we have people of all ages utilizing the park from dawn to dusk.

COVID-19 Programs and Facilities:

The Gibson Aiken Center remains closed to the public. However, on-site visits are acceptable if the individual complies with the following Town requirements.

- 1) No one may visit the Gibson Aiken Center if they are experiencing any symptoms of respiratory distress (fever, cough, shortness of breath).
- 2) Only 1 visitor will be allowed in any office at any given time.
- 3) Visitors who do not make an appointment in advance may have to wait outside the building until it is their turn to enter.
- 4) During the visit, the 1 employee and 1 visitor will always wear masks, wear gloves, or use hand sanitizer and abide by social distancing best practices such as standing no closer than 6 feet apart.

The Brattleboro Senior Center opened for indoor programming Monday July 20TH. Patrons are required to call in and reserve a time slot for each program, no more than 20 patrons are allowed in the at any given time, we ask that all patron social distance and wear masks.

Brattleboro Senior Meals continues to serve over 140 Meals on Wheels Daily.

Status of facilities:

- The Fred H. Harris Tennis/Pickleball Courts at Living Memorial Park are open.
- The Rotary Disc Golf Course at Living Memorial Park remains open.
- The Men's League started their games on Thursday July 9TH. The league has implemented several safety measures to comply with COVID 19 re-start play guidelines. The Women's League has chosen not to play this season.
- The Basketball Hoops at Living Memorial and Crowell Lot have been reinstalled.
- The Dog Park at Living Memorial Park is open.
- The Living Memorial Park Pool opened for the season on Saturday June 20TH.
- All (5) Playgrounds are open with COVID 19 Signage/Guidelines on
- Restrooms at Living Memorial Park and West River Park Ball Fields will be opening on Thursday July 9TH and will be cleaned and disinfected regularly throughout the day.

We continue to encourage everyone to enjoy our facilities and green spaces while following the above guidelines and the following:

- Keep Social Distancing (everyone wears masks + stays at least 6-feet apart whenever possible).
- Organized contact sports/games with spectators are allowed at this time providing COVID 19 re-start play guidelines are being followed.
- Please use the "Arrive, Play and Leave" approach to using these facilities.
- No gatherings of more than 150 people.

We continue to take reservation for Park Rentals providing groups can socially distance and keep their group size to no more than 150. Kiwanis Shelter rentals are being capped at 50 due to the limited sq. footage available at the facility.

Programming:

We kicked off our youth soccer, gymnastics, and field hockey programs the week of September 14TH. All involved coaches, players, officials, and parents are all doing a great job with wearing mask and social distancing when possible. All the games are being played in-house. The Soccer & Field Hockey Officials are using electronic whistles.

We have delayed the opening of the Nelson Withington Skating Facility to November 21 (tentatively). We are waiting to hear further guidelines from the state regarding High School Hockey before moving forward with the opening of the Skating Facility as BUHS is one of our largest user groups.

Due to the lack of participants we did not run our re-mote days Gibson Aiken Day Camp.

The Annual Horribles Parade & Brattleboo has been canceled for this year. However, we have regrouped and are collaborating with other Town Departments (Brooks Memorial Library, Fire Dept & Police) to sponsor a drive-thru trick-or-treating event in the Municipal Center Lot on Saturday Oct. 31 from 4:00 – 6:00 PM..

Due to COVID The Annual Phil and Mary Dunham Ski, Skate, and Snowboard Sale has been canceled this year. The event is typically schedule for the first weekend in November.

We are planning on opening the Gibson Aiken Center for afterschool and evening activities the week of October 26TH (pickleball, volleyball, badminton, group fitness classes, and basketball shooting/skills & drills). We are waiting on further guidance from the state regarding offering youth and adult indoor basketball leagues.

Summary of Major Activities and Work Projects:

THE FINANCE DEPARTMENT HAS MOVED FROM THE 2ND FLOOR OF THE MUNICIPAL CENTER TO SUITE 104 ON THE 1ST FLOOR.

1. The Red Clover Commons project has been issued a Grant Agreement; the Selectboard accepted and appropriated the Grant on October 6, 2020. The Subgrant Agreement will be signed on Tuesday, October 13, 2020.
2. Groundworks' has been issued a Grant Agreement, which is on the 10/20/20 Selectboard Agenda to accept and appropriate.
3. A VCDP application has been submitted for 47 Flat Street, to be renovated into affordable housing units, and another for Brattleboro Housing Partnerships for Covid relief.
4. Collections for 1st quarter tax payments due September 15, 2020 are down slightly due to late filing of tax returns and corresponding State payments; and utility collections are down due to lack of shutoffs.
5. The Treasurer's office has 10 properties still in the tax sale process, with several of those expected to be paid prior to tax sale.
6. Year-end work to complete the FY2020 financials is on-going; auditors are now scheduled for October 15th for final fieldwork.
7. An application has been submitted to FEMA for initial emergency supplies in response to the Covid 19 pandemic. Our application for actual and anticipated Covid-19 expenses to the State of Vermont was approved; the process has begun to submit for reimbursement.

Summary of Major Activities/Work Projects:

- **Planning Activities and Projects**
 - Prepared and presented an Interim Zoning Bylaw to allow for the creation of additional housing units. Since Selectboard adoption of the Interim Zoning Bylaw, 2 permits were issued for units that would not have been allowed without the interim zoning. Administrative approval allows for use of COVID funding due to the quicker approval time. Additional units are in the pipeline under the new ordinance and funded by COVID relief funds: 2 new units at an existing 2 unit building on Western Ave; 1 new unit at an existing 2 unit on South Main Street, and 4 new units on a property with a second 9 unit building.
 - Finalized an Interpretive Sign that will be installed on the new Hinsdale Bridge.
 - Assisted with Windham Regional Commission's crosswalk count study of South Main/Canal Street.
 - Collaborated with Conservation Commission on developing a series of interpretive signs along a portion of the West River Trail as part of the Tiny Grant.
 - Submitted the 2021 Municipal Planning Grant application to apply for funds to develop a housing action plan.
 - Andrew is now serving on the Quality Youth Development (QYD) Steering Committee. QYD is a community wide initiative being organized by Building a Positive Community (BAPC) that seeks to "support, engage, inspire, and empower youth" through the completion of 10 community benchmarks."
 - Planning Director provided testimony to the House General Committee on S.237 which contains provisions related to Tri-Park Housing Cooperative.

- **Administrative Officer/Zoning Report**
 - Land transactions continue at a fast pace with one to two requests for Bianchi letters or permit searches per day.
 - We received 17 permit applications and 18 issued. Permits included a single-family home.
 - Violations for garbage, bedbugs and stormwater were issued.
 - Planning for resumption of the school reunification group meetings began.
 - Planning for the HMP rewrite progressed, with a survey for public outreach being developed.
 - Andrew and Brian took a state training on LHMP plan preparation; the state has taken

Town Interdepartmental Collaboration: We were happy host Town Meeting representatives and offer wi-fi and tech support. We worked with Rec & Parks staff to plan for a school age day camp program and look forward to increased collaborations with the department. I attended several sessions at this year's virtual Town Fair.

Buildings and Grounds: Work Today folks continue to spiff up the surrounding area. Our garden fence and the rails along Main St. now sport a shiny new coat of green paint. We also have a new gardening volunteer who will work with our long-time gardener resurrect the space. We have also requested a quote for replacing the hallway carpet on the second floor. DPW has been working with us to replace the sidewalk area directly in front of the Main St. entrance.

Projects, programs, activities: The Children's Room is allowing class visits in small groups again during the mornings when we are closed. The CR staff is also preparing take-home activity bags for families. We have purchased several Zoom licenses to use for virtual programming, and we will offer to "loan out" meetings for community groups. We prepared a physical and virtual "display" commemorating Justice Ginsburg's contributions, (and added a lace collar to our Spirit of Life statue), and featured a Banned Books Week edition of our e-newsletter.

Community Collaboration: BML is working with a group of community agencies which will apply for a United Way grant to create and distribute "care packages" to those impacted by COVID-19. I participated in the monthly Community Equity Collaborative meeting. **BML staff was honored to be recognized as "Unsung Heroes of the COVID era" by Compassionate Brattleboro.**

Generosity: The Friends of the Library have finalized their fundraising letter for their annual appeal, which will support enhancements in service, such as programming, streaming video, etc.

Professional activities: I have benefitted from many helpful supportive meetings with library colleagues in Vermont as we grapple with the procedural and personnel issues associated with reopening our facilities. Staff has participated in many webinars and attended online lectures and classes, and online conference session, (e.g. a workshop on food literacy, the Doerr Center for Social Justice's Annual lecture, presented by Dr. Ibram X. Kendi, the Association of Small and Rural Libraries Annual Conference, etc).



SUBJ: SEPTEMBER 2020 MONTHLY REPORT

Summary of Major Activities/Work Projects:

Officers responded to 831 calls for service/incidents and made 63 arrests resulting in 87 criminal charges. Included in these calls for service were 7 overdoses with 0 resulting in death. This does not mean there were only 7 overdoses in Brattleboro for this period. It merely means that these are the numbers that were responded to by police.

21 vehicle operation citations were issued along with 171 warnings. Officers spent approximately 224 hours on foot patrol in the downtown area as well as other neighborhoods and parks in Town.

Special Meetings/Communications/Events:

Officer's and staff continue to make numerous appearances throughout the community and communicate by electronic means to meet and discuss citizen concerns. The topics included excessive force, personal safety, crime trends, homelessness and internet safety. The Brattleboro Police Department continues to make strides in educating and informing the citizens of our activity and to solicit their feedback on how we can improve our services.

Budget Concerns/Impacts:

Monitoring the FY 2021 budget.

Staffing:

The Department currently has 6 openings. Officer Busch recently resigned along with Jared Matos who resigned while attending the Vermont Police Academy. We hope to hold interviews soon with the 4 applicants we have on file. We are advertising locally and regionally to solicit applicants. College job fairs throughout New England and New York are currently suspended for safety reasons due to the COVID-19 pandemic which has made our recruiting efforts not as successful as we would like. We are exploring virtual options for recruitment and interviews.

COVID-19

As the Town of Brattleboro responds to COVID-19, the men and women of the Brattleboro Police Department remain steadfast in our commitment to maintain public safety, uphold the law and safeguard the well-being of our community. Our department is working closely with other law enforcement agencies, Dept. of Public Safety, and the State's Attorney Office to help reduce the spread of COVID-19.

We are in normal operations with an emphasis on safety. We are following the directives and recommendations set for by local, state and federal subject matter experts.

All patrol shifts remain fully staffed as there has been no change to our schedule.


