COVID-19

During this month, Public Works has continued to fight the spread of COVID-19. We have instructed staff to perform all essential tasks while working as separately as possible, staff who are able have been working remotely and crews have been instructed to have no more than one employee per vehicle while driving. As we watch the number of new cases in Vermont plateau a bit, we're confident knowing that we're doing our part to stop the spread and lessen the curve.

Highway Division

In April the Highway Division was busy patching potholes, repairing gravel roadways and repairing/replacing signs. The street sweeper started the process of cleaning our paved roadways and parking lots. This year we will start in the West Brattleboro section of Town first and then continue until every paved road is swept. The process normally takes three months. The downtown area is swept two times a week.

Maintenance Division

The Maintenance Division focused on removing, repairing and storing the winter maintenance equipment. They also ensure the sweeper, mower, catch basin cleaner, line striping machines and other specialized construction equipment is operational and ready to go for the season. This month, we welcomed Stuart Wheelden to the crew. Stuart grew up in the area and has worked locally for many years as a skilled mechanic.

Distribution & Storage

The Distribution and Storage crew started the process of flushing water mains both during the day and overnight. This procedure takes place two times a year and is essential to the proper operation of water distribution system. Due to the COVID-19 pandemic, this division has continued to limit contact with the public which has hindered meter reading, 'call backs' for meter issues and meter replacement. Staff worked on inventory and has also been performing routine operations such as sewer maintenance, hydrant maintenance, vehicle maintenance, and various service calls.

Water Treatment

Water Treatment staff test the water daily and are under contract to operate the Welcome Center and the Algiers water system. They continue to do all the daily maintenance of the all the water facilities and patrol the watershed. Staff has been maintaining required certification requirements by attending courses and classes on water treatment. AL Tyler has been working with staff to install a replacement soft start pump drive at the Retreat Wells.

As always, our facilities are available for public tours and we encourage awareness of our system.

Wastewater Treatment

Wastewater Treatment staff continues to perform routine Plant and pump station operations. They

continue to complete all statutory testing as required by our licensure by both State and Federal agencies. The Plant continues to operate in compliance with all permitting requirements.

The sludge dryer pilot program continues and staff continues coordinate with consultants in an effort to control odors.

Administration

Typically, at this time of year, administrative staff is busy planning projects for the upcoming construction season however, given the unprecedented COVID-19 global pandemic situation, all spring projects are currently on hold.

Summary of Major Activities/Work Projects:

- 1. General COVID-19 Operations** – Due to the COVID-19 pandemic, beginning March 26 all of our staff began working remotely. One staff member has been going into the office when the mail is available to process document requests, dog licenses and land recording. We have still been available to the public by phone and email to answer any questions and help in every possible way. We continue to process voter registrations online, and are catching up on many data entry and cemetery mapping and indexing projects. Our team is staying busy and being as creative as we can to continue to serve the public. Along with the rest of the Town offices, we are gearing up for our Phase-I soft opening to the public on May 4, in accordance with the procedure put out by the Town Manager's office.
- 2. Representative Town Meeting** –Due to COVID-19, RTM was canceled by the Selectboard and will be re-warned when appropriate. Currently, District 1 still has seven open seats, and District 3 has one open seat due to the resignation of the incoming Selectboard member.
- 3. August Primaries and November Generals** – Discussions are beginning around how to hold the upcoming elections. We are waiting on decisions to be made by the Secretary of States of office so that we can begin planning. It is anticipated that planning will begin in May. All voters are encouraged to update their registration and mailing addresses, and request ballots by mail.
- 4. Liquor/Entertainment License Renewals** – Renewal liquor and entertainment licenses continue to be processed. All renewals were approved by the Selectboard in February and have been sent to the DLC for processing and approval. Due to COVID-19, the DLC has extended the deadline for renewals until June 30, 2020, for any business that has not yet renewed.
- 5. Dog Licenses** – 2020 dog licenses continue to be issued. Due to the COVID-19 pandemic, late fees have been waived until further notice. While the late fee after the April 1 deadline has been waived, dogs are still required to be licensed per statute. We estimate that we have issued 758 2020 licenses, and there remain approximately 494 unlicensed dogs in town for 2020. Licensing has been slower than normal due to the pandemic.
- 6. Brattleboro Cemetery Committee** – The committee's April meeting to continue the discussion on green burials will be rescheduled for a later date, due to the COVID-19 pandemic. Cemetery records are being computerized.
- 7. Vitals and Land Records** – we are processing these as we are able through mail, email and online payments. Staff has only been going into the office when mail is available, so our ability to process these requests has been delayed. We continue to encourage the public to request documents through email, mail, and fax.
- 8.** As time allows, work continues on computerizing cemetery records, digitizing land records and other older town records.
- 9.** Day to day operations continue to operate smoothly.

Communications

The focus and way of life for the Brattleboro Fire Department continues to be COVID - 19. The April report is again a glimpse of the events and adjustments we continue to make in the daily operations;

- Acts of kindness from citizens and businesses continue in the way of donations of food, meals, hand sanitizer, homemade masks, protective equipment, and words of support.
- All “normal” daily functions such as inspections, fire prevention, school visits, outside training classes have been canceled through May.
- Our buildings remained “closed” to the public.
- Meetings with Rescue Inc & BMH are now being held on an every other week basis for planning & resource sharing purposes
- Conference calls are now every Thursday with VT Emergency Management and include VT Department of Health, VT EMS, Office of the Medical Examiner, Dept of Public Safety, and others.
- Updated guidelines from the State or CDC on PPE and patient care continue to be released regularly
- Inventory on medical PPE is done weekly so numbers can be compared, a “burn rate” can be established and a reorder date is determined. Supply and restock at BFD has been adequate
- Situational Updates are now completed and distributed on a once a week basis.
- School Meals Program continues distribution from both stations
- The shifts have participated in a few “drive by birthday parties” in the last month
- On May 14 in an effort to expand COVID-19 testing, the Vermont Department of Health will be in Brattleboro to run a test site for frontline, healthcare workers and first responders. This is one of several throughout the state.
- We have responded to several non – permitted burns this spring. Reminder that people need to obtain a permit and can burn only yard/garden debris

Staff

- Staff “health screens” twice a shift, once when they come in to work at 8a and then again at 8p.
- Meals are being eaten in the Meeting Hall where social distancing can be maintained
- Following the guidance on wearing a mask in public
- Shift Roll Calls and many trainings are done via video conferencing to keep the stations staff separated
- On coming and off going shifts do not mingle and stay separated.
- C2 is back working out of Central Station
- Office Manager continues on a schedule of a maximum of 2 days a week in the office, the rest is work from home.
- Staff continues to make several “grocery store and pharmacy runs” at the request of a few high risk citizens
- Daily training sessions continue while always using social distancing. Topics have included COVID – 19 (of course), aerial ladder operations, water supply, rope rescue and many companies have offered free webinar training during this time which the shifts have taken advantage of.

Notable Incidents

- April 8 – Building fire in Guilford
- April 8 – Building fire in Keene
- April 12 – Cover truck to Hinsdale for several hours while they were at a mill fire in Ashuelot
- April 25 – 2 ½ acre brush fire on Orchard St caused by non – permitted burn. Assisted by several mutual aid towns with brush trucks and ATV’s
- Several overdoses in April continuing into May

Budget Concerns/Impacts

- A few line items are over budget and a few are running high but overall, the bottom line is still below the time in the fiscal year
- I have made several purchases that normally wouldn’t be made due to the COVID – 19 epidemic. Due to the VT emergency declaration it is hopeful these purchases will be covered by federal monies.

- ***Full and healthy staff as of this writing*** – no isolations or quarantines

Summary of Major Activities and Work Projects:

1. On July 2, 2019 VCDP awarded a \$300,000 grant to the Town (Brattleboro Housing Authority as sub-recipient) for the Red Clover Commons development. The Brattleboro Housing Authority's request for an extension in order to satisfy the award conditions has been approved. The Town is awaiting award conditions.
2. Billed approximately 3,570 utility customers in April. Mailed 228 past due utility notices on April 10th. Tax Sale took place on October 23, 2019. The Town was the only bidder on the former Country Kitchen building. The Town paid \$11,359.20 for the property and the owner has one year to redeem the property before the Town takes ownership of the building.
3. The Town was awarded a \$375,000 scattered site grant from VCDP on behalf of the Windham Windsor Housing Trust. The Windham Windsor Housing Trust has satisfied the award conditions and a Grant Agreement has been issued for signatures.
4. Groundworks' \$500,000 grant application to assist with the construction of a new facility has been submitted to VCDP. The application was considered by the VCDP board at its April 4, 2019 meeting and has awarded a \$400,000 grant for the project. Brattleboro has not yet received a draft grant agreement between the Town and VCDP for the Groundworks project. The Town has committed \$50,000 to the project as a grant from Program Income funds. An additional \$100,000 appropriation from Program Income funds was approved at the July 9, 2019 Selectboard meeting.

Summary of Major Activities/Work Projects:

Skatepark Project:

I have sent a letter of intent to Parker Construction. Due to COVID-19 the project has been on hold. Parker Construction is in a holding pattern at this time to ensure he will be able to receive all his material needed for the project before moving forward.

Outside Contractors:

Independent Landscape and Property Management has completed the spring clean-up of Prospect Hill and Morningside Cemetery. The week of April 27TH they started mowing and trimming at the Cemeteries.

COVID-19 Programs and Facilities:

All regularly scheduled programs have been canceled until further notice.

The spring sports season (T-Ball, Small Fry Baseball, Youth Softball, Boy's & Girl's Lacrosse, and Men's and Women's Softball) was canceled.

The Gibson Aiken Center is closed to the public. However, on-site visits are acceptable if the individual complies with the following Town requirements.

- 1) No one may visit the Gibson Aiken Center if they are experiencing any symptoms of respiratory distress (fever, cough, shortness of breath).
- 2) Only 1 visitor will be allowed in any office at any given time.
- 3) Visitors who do not make an appointment in advance may have to wait outside the building until it is their turn to enter.
- 4) During the visit, the 1 employee and 1 visitor will wear masks at all times, wear gloves or use hand sanitizer and abide by social distancing best practices such as standing no

closer than 6 feet apart.

Brattleboro Senior Meals continues to serve over 140 Meals on Wheels Daily.

Status of facilities:

- The Fred H. Harris Tennis/Pickleball Courts at Living Memorial Park are open.
- The Rotary Disc Golf Course at Living Memorial Park remains open.
- All softball fields are available to families for informal kickball, wiffleball etc. Softball fields are not yet open for more formal team activities (games or practices).
- Basketball courts at Living Memorial and Crowell Lot remain closed until further notice.
- The Dog Park at Living Memorial Park remains closed until further notice due to COVID-19 and being recently re-seeded to rejuvenate the turf.
- All park equipment remains closed (benches, picnic tables, playgrounds etc.) until further notice because as it is impossible to sanitize that equipment in between users.
- Restrooms at Living Memorial Park and West River Park remain closed until further notice.

We encourage everyone to enjoy our facilities and green spaces while following the above guidelines and the following:

- Keep Social Distancing (everyone wears masks + stays at least 6-feet apart whenever possible).

All of our Community Garden Plot at Stockwell Drive have been reserved and all the gardeners are busy prepping for the season.

Staffing:

The Assistant Director & Administrative Assistant are back working in the Office. The Program Coordinator is working from home and comes into the Office when necessary. Staff is working on new procedures for offering summer programming/camps in accordance with new guidelines put out by the Governor. In addition, Staff is working on virtual programming during COVID-19.

The Parks employees are working their regular schedule. Staff is following all health and safety protocols recommended by the Governor for staff working in groups.

We have started the summer employment process (Pool Manager, Water Safety Instructors, Lifeguards, Cashiers, Pool Checkers, Seasonal Maintenance, and Summer Camp Counselors). All summer seasonal staff have been sent tentative employment offer letters.

 - Worked on three zoning violations for fowl. Enforcement needing in person inspections still halted.
 - Sought ways to allow for rapid responses for businesses working to respond to health guidance.

- **Sustainability**
 - Facilitated development of a supply chain and network of sewers to make cloth masks. Providing a website, email platform, social media guidance, and found numerous sources of in-kind donation. These sewers have provided over 5500 masks and 50 gowns, prioritizing first responders and others on the front lines. There is now a form for facilities to submit requests to the group, and an empowered Peace Corp alum who is leading the group well.
 - Facilitated discussion among members of the Community Food Farm Action Team that has resulted in the development of a number of community collaborations and a shared campaign for community gardening, the Growing Resilience campaign. More to come, this is in process. This enjoys much appreciated support from Edible Brattleboro, BAMA, Retreat Farm, and Strolling of the Heifers.
 - Participated in meetings to coordinate with mutual aid organizers across the state and learn from other's work. Led development of a regional resource guide that comprehensively mapped offerings in Windham Region, hosted by the WRC.
 - Met repeatedly with energy coordinators from Bellows Falls, Windham, Wilmington, Bennington, and beyond to discuss how to move energy work forward in the COVID era.
 - Have repeatedly reached out to GMP for more data on Cow Power, trying someone different than before now. Final calculations are coming once the last question is answered.

- Advancing the Furthering Connecting Brattleboro trails project, in partnership with NPS. In progressing well, meeting with all trail system owners have been held. The first group to move forward with a clear next step looks to be Winston Prouty and Delta, who seek to unite their trails in a shared map and next stage of development.

Departmental Monthly Activities Report for April 2020

April was a challenging yet productive month for the staff and services of Brooks Memorial Library (normally a bustling social hub) as we worked to fulfill our mission to “Connect people and resources to inspire, inform and empower our diverse community” from the isolation of our homes.

Much of our time was spent in planning and preparing for phased resumption of services. The Governor’s explicit permission for libraries to offer curbside service propelled us to develop procedures and processes that would allow us to circulate materials to the public efficiently while maintaining the utmost safety precautions for our patrons and our staff. Simultaneously, we began to accept the return of loaned materials, which presented even more complications to ensure everything was handled correctly and sequestered in case of contamination. We worked collaboratively and quickly to consider challenges and to propose solutions. So far everything is operating smoothly and the community has expressed its gratitude repeatedly. Another standard aspect of library service that requires radically new and complex planning is our summer reading program, which will be completely different this year. In essence, we are creating our program from scratch, as we need to have a few different scenarios planned.

Programs/activities: Our dedicated staff worked diligently to serve the public through creating online activities, (e.g. virtual LEGO activities, fairy house construction, art projects for adults, etc.), and answering reference and reader’s advisory questions on the phone and through email. Others kept up with their work ordering books (including expanding the digital offerings) and keeping interlibrary loan materials current and moving forward. The Children’s Room staff trained in new technologies to devise clever activities and record picture book readings to engage kids online during Spring Break and to celebrate National Library Week. They have also transferred some of their programs like mindfulness and yoga to online experiences and they have significantly increased their Facebook presence, retooled the youth section of our website and created a YouTube channel to promote services and support family activities. Our Circulation Manager, Courtney Carey kept the public informed through our enewsletter and through dynamic mini-websites imbedded in our homepage which allow for nimble updating on the latest developments in the community, the library’s offerings and information about COVID-19. Reference librarian Jeanne Walsh has been working on a database of community resources and has enlisted the help of other staff and trained them to input information. This vastly expands the reach of our collective knowledge and our helpfulness within the community. And, of course we continued to promote our online resources to the public which have been embraced enthusiastically. Digital media statistics for April totaled 3869 downloads/credits/views compared with 2273 last year.

Professional Development: Jeanne also created an inhouse professional development curriculum for staff to strengthen their skills and deepen their knowledge of BML’s online resources. Staff took great advantage of this opportunity for continuing education by participating in webinars and virtual conferences and workshops on a wide range of topics from *Diversity in the Library* to graphic novels. And, of course we all learned to use ZOOM, Go to Meeting, Trello, Teams, or some means to collaborate at a distance.

Community Collaboration: I continue to meet with the Community Equity Collaborative and have called in to the conversations convened by Rhianna from Groundworks to keep in touch with ways we can help the vulnerable populations in town. Courtney has established several interactive Facebook groups. She is collaborating with Stephen Dotson on a community gardens group and is

working with Building A Positive Community on *Growing Hope*, an initiative to distribute sunflower seeds for Brattleboro residents to plant around town. She also created a website for the community mask makers. Two of our circulation clerks, John Kilduff and Ellen Martyn regularly delivered food to vulnerable populations.

Displays: The Friends of Brooks Memorial Library purchased large signs to adorn our front windows, which colorfully proclaim “TAKE CARE, WE MISS YOU” and another that is a large to-do list of library-related activities. Circulation clerk Klara Charlton created giant instructions for accessing materials and services for display in the other large windows on Main St.

Website project: Jeanne and Chloe have made progress in providing new content.

Trustees: New members Gabriel Sistare and Karen Tyler were appointed by the Selectboard to fill the two vacant positions created by resignations. This allows them to serve prior to RTM where they will be officially nominated and presumably elected.

Promotion: Staff has stepped up our activity on Facebook, both the general BML page and the children’s page. I was interviewed by Teresa Healy for her radio show *We’re All in This Together* and by Wendy O’Connell for her BCTV show *Here We Are*. Peter Case interviewed Carol Lolatte and me on our phased reopening processes.

Once again, I am grateful for the tenacious optimism and community spirit of the BML staff and the Town of Brattleboro. I am especially grateful to our patrons for their love and support of the library, as evidenced by the photo and caption below:



SUBJ: APRIL 2020 MONTHLY REPORT

Summary of Major Activities/Work Projects:

Officers responded to 395 calls for service/incidents and made 5 arrests resulting in 10 criminal charges. Included in these calls for service were 6 overdoses with 3 resulting in death. This does not mean there were only 6 overdoses in Brattleboro for this period. It merely means that these are the numbers that were responded to by police.

No vehicle operation citations were issued along with 5 warnings. Officers spent approximately 280 hours on foot patrol in the downtown area as well as other neighborhoods and parks in Town.

Special Meetings/Communications/Events:

Officer's and staff continue to make numerous appearances to meet and discuss the concerns of the citizens at the senior center, elementary schools, with various organizations and community centers. The topics included personal safety, crime trends, homelessness and internet safety. The Brattleboro Police Department continues to make strides in educating and informing the citizens of our activity and to solicit their feedback on how we can improve our services.

There were several meetings held with various neighborhood groups to address the recent surge in larcenies and attempt of larcenies from vehicles. This issue was also addressed several times during the public participation segment of the Select Board meeting. There was also a community forum at the Brooks Memorial Library on 29 February 2020 which was well attended. Represented on the panel were members from the Brattleboro Police Department, Town Government, State's Attorney's office, Restorative Justice State Representatives. The event was very well attended.

Budget Concerns/Impacts:

Monitoring the FY 2020 budget. Preparing to present the FY2021 budget at RTM.

Staffing:

The Department currently has 4 openings. A background check is being conducted on 1 applicant to attend the August 2020 110th Vermont Police Academy Basic Class. We are advertising locally and regionally while attending numerous college job fairs throughout New England and New York. The Brattleboro Police Department is continuing to accept applications.

COVID-19

As the Town of Brattleboro responds to COVID-19, the men and women of the Brattleboro Police Department remain steadfast in our commitment to maintain public safety, uphold the law and safeguard the well-being of our community. Our department is working closely with other law enforcement agencies, Dept. of Public Safety, and the State's Attorney Office to help reduce the spread of COVID-19.

As the Town's response to this pandemic evolves, so does BPD's response. In the midst of dealing with COVID-19, law enforcement is one of the jobs that can't be done from home. Here are some of the measures we're taking to protect sworn members, civilian staff and the public from exposure:

There is one specific change that people will notice when they call for medical assistance and that is the question of if they're experiencing flu-like symptoms. The specific reason dispatch is asking that is to make sure that the 1st responders coming to your call are wearing proper equipment. It has no relevance on whether we're coming.

When officers do have to respond in person, they are being encouraged to take steps to limit contact. Officers will ask you to step outside and will avoid going inside your home if possible.

We are now only taking non-emergency reports via phone or online. It is another piece of social distancing we're trying to practice, and we want to make sure we model that with the community that we are doing proper social distancing as well. Our number one priority is and has always been violent crime. For reports of violent crimes and crimes in progress, we will continue to respond to the scene.

Sick employees are instructed to notify their supervisors, stay home and do not come to work.

Members are instructed to wash hands frequently with soap and water for at least 20 seconds and/or utilize an alcohol-based hand sanitizer.

All external and internal in-service training not related to COVID-19 has been suspended. We are exploring options for video training.

Roll Call is conducted with maximum separation and has even been held outdoors where it's less likely officers will spread the virus to each other.

Public access to the police stations is restricted. If a member of the public needs to meet with an officer, they will be met in front of the building.

We are accepting public records requests through our website; however, the requests will not be completed until our records division is back to work.

To limit face-to-face interactions with the community, we have suspended our in-person community engagement programs.

We are encouraging employees to work remotely when possible. While this isn't possible for patrol officers and many other positions, some employees, such as support staff, are working from home.

All patrol shifts are fully staffed as there has been no change to our schedule.

We are empowered to issue citations for violations of Governor Scott's Executive Order No. 01-20, "Declaration of State of Emergency in Response to COVID-19." However, our approach is to focus on education, rather than enforcement. I have witnessed our citizens doing their part and believe they will continue to do so. The critical goal of this order is to inhibit the spread of Coronavirus. Please remember-our elders and community members with compromised immune systems are most at risk when we do not follow these commonsense health guidelines. It is critical that we all are partners in this process.


Through the month April we continued practicing the previously mentioned procedures. We are currently in the process of slowly integrating our employees who have been working from home back to the police department. This has been mainly our administrative staff. The integration consists of rotating employees throughout the week while adhering to the guidelines set forth by Town Manager Elwell. We are anticipating for the State's Attorney's office to start accepting non-emergency cases soon as well as the court's conducting arraignments.

The reduction of pro-active policing is reflective in the motor vehicle enforcement, arrest and community policing data. We are looking forward to the time when we can safely return to our pre-pandemic activities of interacting with all the members of our community.
