**COVID-19**

During this month, Public Works has continued to fight the spread of COVID-19. We have instructed staff to perform all essential tasks while working as separately as possible. As we watch the number of new cases in Vermont plateau a bit, we're confident knowing that we're doing our part to stop the spread and lessen the curve.

**Highway Division**

The storms this month have brought hard rains that have caused a lot of erosion and need for road and driveway repairs. Crews have been ditching and hydroseeding on Ames Hill through the Grants-In-Aid program. Culverts on East Orchard Street, Meadowbrook Road and Hescocock Road were dug out and many of the Town's bridges were washed. Staff has been coordinating with Dave Manning to assist in the building of the Town's new skate park.

This month, the crew performed routine seasonal operations such as repairing storm drains, brush removal and roadside mowing. The crew also tended to the gravel roads, grading, raking, and applying calcium chloride.

**Maintenance Division**

As always, the Maintenance Division's focus is keeping the fleet fully operational and safe through-out our daily operations. Maintenance Staff has been assisting the Fire Department with some general maintenance of some of their vehicles. This month, in addition to general maintenance of the fleet, the staff has been mowing the lawn at the Fairground Rd facility and working on general building/grounds maintenance.

**Distribution & Storage**

This month, crews completed the curbing at Chestnut Hill in preparation for the Highway Crew to pave the road next month. A hydrant and 16" valve were installed on Reservoir Road in preparation for the new waste line from Pleasant Valley. Staff conducted hydrant flow testing this month.

In addition to the above operations, the crew has been doing routine summer work such as painting and mowing around hydrants as well as mowing right-of-ways.

**Water Treatment**

Water Treatment staff have been working on watershed maintenance and repairs to Pipeline Road. Staff tests the water daily and are under contract to operate the Welcome Center and the Algiers water system. They continue to do all the daily maintenance of the all the water facilities and patrol the watershed. Staff has been maintaining required certification requirements by attending courses and classes on water treatment.

## **Wastewater Treatment**

Wastewater Treatment staff continues to perform routine Plant and pump station operations. They continue to complete all statutory testing as required by our licensure by both State and Federal agencies. The Plant continues to operate in compliance with all permitting requirements.

The sludge dryer pilot program continues and staff continues coordinate with consultants in an effort to control odors.

### Summary of Major Activities/Work Projects:

- 1. General COVID-19 Operations** – Due to the COVID-19 pandemic, beginning March 26 all of our staff began working remotely. One staff member had been going into the office when the mail is available to process document requests, dog licenses and land recording. We have still been available to the public by phone and email to answer any questions and help in every possible way. We continue to process voter registrations online, and are catching up on many data entry and cemetery mapping and indexing projects. Our team is staying busy and being as creative as we can to continue to serve the public. Along with the rest of the Town offices, we began our Phase-I soft opening to the public on May 4, in accordance with the procedure put out by the Town Manager's office. At least one staff member has been in the office daily from 8:30am to 5pm, with appropriate breaks. With the upcoming elections, we have been functioning at full capacity in the office, as needed.
- 2. Representative Town Meeting** – Due to COVID-19, RTM was canceled by the Selectboard and will be re-warned when appropriate. Currently, District 1 still has eight open seats, District 2 has one open seat, and District 3 has two open seats.
- 3. August Primaries and November Generals** – Preparation for the Primary election is well under way. A significant number of absentee ballots are being mailed out and returned daily. The BCA has laid out a plan for a social distance floorplan for the August election at the American Legion. All voters are encouraged to return their ballots using the drop box in the Municipal Center parking lot, or bring them directly to the polls on August 11. The General Election will be held on November 3 at the American Legion. The Secretary of State's office will be mailing ballots to all active registered voters in early October.
- 4. Board of Civil Authority** – The Board met on July 13 to open two Property Tax Assessment Appeal Hearings, and continued those hearings on July 22. Decisions will be made on August 5, 2020. The Board also met on July 22 for a pre-election meeting and with the Secretary of State's office for election trainings the week of July 27.
- 5. Cemetery Committee** – The Cemetery Committee will meet this month for their Organizational Meeting. The meeting date and time has not yet been set.
- 6. Board of Abatements** - The Board met on July 13 to hear seven abatement requests. The Board granted four requests in the amount of \$91,124.38, which included uncollectible tax accounts requested by the Treasurer's office, and denied three requests.
- 7. Dog Licenses** – 2020 dog licenses continue to be issued. Due to the COVID-19 pandemic, late fees have been waived until further notice. While the late fee after the April 1 deadline has been waived, dogs are still required to be licensed per statute. We estimate that we have issued 1036 2020 licenses, and there remain approximately 218 unlicensed dogs in town for 2020. Licensing has been slower than normal due to the pandemic.

8. **Vitals and Land Records** – we are processing these as we are able through mail, email and online payments. We continue to encourage the public to request documents through email, mail, and fax.
9. As time allows, work continues on computerizing cemetery records, digitizing land records and other older town records.
10. Day to day operations continue to operate smoothly.

## Communications

Normal operations have resumed at the Brattleboro Fire Department with some COVID – 19 precautions still in place.

- Platoon #1 flow tested 5,050' of 1.75" hose. During that testing it was found that the inner liner of the hose was separating from the outer jacket (delamination), which greatly restricts the flow of water through the hose. Because of this we have removed 17 lengths of 1 3/4" hose (850') from service and ordered replacement hose.
- Members from BFD (Streeter, Casabona) attended a Swiftwater Technician training.
- Brattleboro Dive Team assisted Brattleboro Water Treatment Plant personnel at Pleasant Valley Reservoir with cleaning intake screens.
- All members of BFD were fit tested for SCBA's masks. This is done annually to ensure each member is getting a proper fit/seal with their air mask.
- 10 Bloodborne Pathogens classes were given to Town Staff by Capt Keir.
- School Meals Program continues will continue distribution from both stations through August.
- Union President Captain Keir, HR Director Sally Nix, C2 & C1 held a meeting to talk about recruiting strategies for the future.
- We have taken possession of a former PD SUV. BFD staff removed all of the PD logos/stripping and cleaned the vehicle up. DPW mechanics are now doing some needed repairs and it will then come back to BFD for upfitting.
- Several staff members recently participated in a "high performance" CPR training. This now finishes up all staff in the training on this new technique.
- A member of BFD, also a member of the VT USAR Team, was activated for Tropical Cyclone Isaias

## Staff

- Staff continues with "health screenings" twice a shift.

### Notable Incidents

- BFD responded to 16 emergencies during the evening of August 4 as Tropical Cyclone Isaias moved through the area. Most were trees/power lines down and there were 3 structures hit by falling trees. There was a widespread power outage for a couple of hours and several residents went without power through the night. Thanks to BPD, DPW and Green Mountain Power for their great teamwork which certainly lessened the impact.

### Staff news

- We have received 6 application for the open position created by the departure of Alex Morin. Four have been invited to take the written test scheduled for August 14. Those who score a 70% or higher will be invited to participate in the oral boards on August 20. From there it is on to the Chiefs' Interview on August 26
- Probationary FF Steve Pellicano is progressing well. Closing in on the 6-month mark, Steve is working and training hard. He is presently being put through the paces on driving and operating an Engine. I hope to see him in the driving rotation by the end of August.

### **Why is it so important that we wear masks?**

As the COVID-19 pandemic progresses, it's more important than ever to wear a mask or face covering when in a crowded space (indoors or outdoors) or if you cannot stay six feet apart from people you do not live with. In fact, face masks have been shown to be one of the most effective ways to prevent the spread of COVID-19.

Summary of Major Activities/Work Projects:

In the Assessment Office during the month of July the Grand List was Lodged with the Town Clerk July 2. The office provided Grand List information to the Finance Director to assist them in setting tax rates. The office worked with the Listers in preparation for Board of Civil Authority hearings held July 22 on the GoToMeeting platform.

Staff attended a Bloodborne Pathogen Exposure training at the Central Fire Station.

The Town Assessor has been asked by Property Valuation and Review to be on a Municipal Review Committee for the new Grand List Software awarded to Axiomatic. There was an introductory meeting via GoToMeeting in June with follow up meetings to be determined.

The Office continues to be staffed during regular office hours by one staffer at a time, while working remotely if not scheduled at the Municipal Center. The Assistant Assessor was out the last week of July for vacation. The Town Assessor celebrated her 57<sup>th</sup> Birthday.

**Summary of Major Activities/Work Projects:**

**Skatepark Project:**

Parker Construction with DMI as one of their sub-contractors started the Skatepark Project the week of June 15<sup>TH</sup>. Currently everything has been progressing nicely.

All formwork has been fabricated.

- The Upper Plaza quarter pipe is shaped, and the coping has been installed.
- Both hubba ledges are formed, the C channel has been welded/installed and poured, and all metal has been primed and painted with 2 coats. Some touch up is needed
- All the grades and all features are established
- The bowl is all shaped, the coping has been installed and rebar is currently being installed.
- The A-Frame feature is shaped and ready for rebar. The A -frame rail is fabricated and ready for installation.
- The ledge C - Chanel is all welded, the form is built and ready for installation.
- The quarter pipe at the bottom of the park is all shaped, and the coping has been installed.
- Bonus feature (China Bank) has been shaped, formed, poured (shotcrete) along with being troweled. All the labor and materials were donated by Parker Construction.
- The coping has been shaped and installed for the bonus pocket which connects the quarter pipe to the bank. This feature is another donation by Parker Construction Inc.
- A Majority of earthwork completed - features, grading and swale is still a work in progress.
- The stair rail and flat rail are both fabricated and ready for installation.

### COVID-19 Programs and Facilities:

The Living Memorial Park Pool opened on Saturday June 20<sup>TH</sup> and is scheduled to close on Sunday August 16<sup>TH</sup>. Attendance has been steady over the past month and being open has added to the quality of life of our citizen during this difficult time. We have (2) three-hour general swim sessions daily 1:00 – 4:00 PM & 5:00 – 8:00 PM with a capacity of 75 per session. Several times during each session and in between each session all the high touch areas are being disinfected. To date we have had a total of 3,414 swimmers and this includes our Day Campers that use the Pool between 11:00 AM – 12:45 PM each day.

Summer programs will be wrapping up on Friday August 21<sup>ST</sup>. Due to the delay of the start of the school year to September 8<sup>TH</sup>, we have added an additional week of Day Camp and an additional week of Gymnastics Camp. We been at about 70% capacity for all our camps.

The Gibson Aiken Center remains closed to the public. However, on-site visits are acceptable if the individual complies with the following Town requirements.

- 1) No one may visit the Gibson Aiken Center if they are experiencing any symptoms of respiratory distress (fever, cough, shortness of breath).
- 2) Only 1 visitor will be allowed in any office at any given time.
- 3) Visitors who do not make an appointment in advance may have to wait outside the building until it is their turn to enter.
- 4) During the visit, the 1 employee and 1 visitor will always wear masks, wear gloves, or use hand sanitizer and abide by social distancing best practices such as standing no closer than 6 feet apart.

The Brattleboro Senior Center opened for indoor programming Monday July 20<sup>TH</sup>. patrons are required to call in and reserve a time slot for each program. No more than 20 patrons are allowed in the at any given time, we ask that all patron social distance and wear masks.

Brattleboro Senior Meals continues to serve over 140 Meals on Wheels Daily.

### Status of facilities:

- The Fred H. Harris Tennis/Pickleball Courts at Living Memorial Park are open.
- The Rotary Disc Golf Course at Living Memorial Park remains open.
- The Men's League started their games on Thursday July 9<sup>TH</sup>. The league

has implemented several safety measures to comply with COVID 19 re-start play guidelines. The Women's League has chosen not to play this season.

- Basketball courts at Living Memorial and Crowell Lot remain closed until further notice.
- The Dog Park at Living Memorial Park is open.
- The Living Memorial Park Pool opened for the season on Saturday June 20<sup>TH</sup>.
- All (5) Playgrounds are open with COVID 19 Signage/Guidelines on
- Restrooms at Living Memorial Park and West River Park Ball Fields will be opening on Thursday July 9<sup>TH</sup> and will be cleaned and disinfected regularly throughout the day.

We continue to encourage everyone to enjoy our facilities and green spaces while following the above guidelines and the following:

- Keep Social Distancing (everyone wears masks + stays at least 6-feet apart whenever possible).
- Organized contact sports/games with spectators are allowed at this time providing COVID 19 re-start play guidelines are being followed.
- Please use the "Arrive, Play and Leave" approach to using these facilities.
- No gatherings of more than 150 people.

We continue to take reservation for Park Rentals providing groups can socially distance and keep their group size to no more than 150. Kiwanis Shelter rentals are being capped at 50 due to the limited sq. footage available at the facility.

#### **Staffing:**

The Assistant Director, Administrative Assistant, and the Program Coordinator are back working in the Office and in the field running camps/programs.

The Parks employees are working their regular schedule. Staff is following all health and safety protocols recommended by the Governor for staff working in groups. In addition, assisting with ensure the Living Memorial Park facilities, Day Camp Areas and the Swimming Pool and being cleaned and disinfected on a regular basis.

Staff is working on plans as to how we can safely run our fall youth sports programs (field hockey and soccer) and ways to safely open the Nelson Withington Skating Facility. Additionally, we are looking into how we can offer remote days programming to school age participants.

**Summary of Major Activities/Work Projects:**

  - Contracting with Dufresne Group for Western Ave. Bike Lane scoping study
  - Finalizing draft of the Downtown Design Plan
  - Assisted Town Clerk with survey of RTM members
  - A Rental Housing Vacancy Survey was emailed to landlords for whom we had an email address for (from the Rental Housing Registration database): received 68 responses reporting on a total of 512 units (about a 40% response rate); Key findings:
    - 10 vacancies from the 512 units were reported. This represents a 1.9% vacancy rate.
    - 86% of respondents do not keep a waiting list; 83% of respondents said that their units are vacant 1 month or less
    - Released a housing vacancy survey to the Rental Owner Registration list.
  - Completed quarterly report for Brownfields grant; grant reporting for the VCDP Tri-Park Grant
  - Corresponded with VTrans staff to discuss potential changes to private property due to right-of-way acquisitions
  - Worked on Interpretive Signage for the new Hinsdale Bridge

- **Sustainability**
  - Worked on a communications plan and proposal for carbon reductions/offsetting with the Energy Committee. Recruited new members. Developed a process to produce an annual Energy Report. Currently organizing an energy data-collection protocol that will gather from all Town departments in a regular, orderly way.
  - Planned for the re-launch of the Ag. Advisory Committee, recruited new members for the Conservation Commission.
  - Worked with USDA Rural Development, National Park Service, Windham Regional Commission, the Rail Trail Conservancy, and the Monadnock Regional Rail Trail Collaborative to develop a joint proposal to unite regional trails, focusing on Brattleboro's vital River Connector rail w/trail opportunity. Also, helped facilitate the launch of a scoping project for a bikeable path connecting the Winston-Prouty and Delta campuses, with the assistance of NPS funding and technical expertise.
  - Distributed 200 yards signs for the Growing Resilience campaign to community hubs (Retreat Farm, Winston-Prouty, River Garden), updated the GrowingResilience.info website, and helped launch the Growing Together school gardening-at-home program with BAPC/Youth Services. In the process of coordinating an event series to capture/preserve the increased amount of gardened produce. Strategized with DBA to creatively source produce from gardens for the Everyone Eat's! meal distribution program.
  - Introduced the possibility of pursuing carbon sequestration inventorying to the Conservation Commission as part of the overall Town foot-printing process towards carbon neutrality.
  - Attended webinars on carbon inventorying, local/regional food systems planning, and trail development.
  - Joined the New England Municipal Sustainability Network.
  - Strategized with BDCC's new internship coordinator on funding opportunities and collaboration towards internships for sustainability-oriented nonprofits in Brattleboro. Met with some young adults new to the region who were looking for employment and networking in the sustainability sector locally.
  - Along with the Town Manager and Assistant Town Manager, vetted an opportunity to work with a local energy company on thermal storage and new demand-response services in Town buildings.
  - Distributed a variety of new reports related to sustainability and COVID-adaptation to numerous local leaders.
  - Met and strategized with the WSESU Climate Crisis Taskforce and had follow-up meetings with school board member Tim Maciel regarding future collaboration and supporting school during COVID. Collaborated with Tara Davis on a plan to develop more outdoor space for use at Oak Grove school.

1. The Red Clover Commons project has submitted award conditions have been satisfied. The Selectboard approved a \$100,000 loan to Red Clover Commons to help satisfy a financing shortfall, but the project has since obtained financing elsewhere. No loan will be issued.
2. The tax rate has been set. Tax bills are being mailed today with a due date of September 15, 2020.
3. The Windham Windsor Housing Trust Scattered Site Grant has been signed and the 1<sup>st</sup> requisition submitted and approved. No change from prior month.
4. Groundworks' is still waiting on a grant award from Vermont Community Development.
5. The State Water Revolving Loan Fund application for water system upgrades has been approved.

## Departmental Monthly Activities Report for July 2020

**Life in the Time of COVID:** We are now open for 20-minute visits for up to 30 people, with entrance on the hour and half-hour from noon-4:30. The 20-minute time periods limit prolonged personal exposure and allow us to clean frequently touched surfaces for 10 minutes between groups. Much of our furniture has been stored and only limited seating is available, to avoid congregating and contact with surfaces. Personal assistance is available within social distance. Patrons are delighted to be able to browse the stacks and choose their own books. Several have teared up upon their visits and have thanked us profusely for making this experience possible. So far, we have not reached building capacity of 30 people, though the children's room has met their limit of 10 people on occasion. Masks are mandatory for staff and public as is hand sanitizing upon entering. Curbside service continues to be strong and is still preferred by many of our patrons. Home delivery for patrons who are unable or uncomfortable coming to the library is growing in popularity. Computer access, along with copying and printing capabilities is our greatest challenge as many tasks cannot be accomplished within the 20-minute time frame, but we have been flexible and will extend time for patrons to complete their work.

**Projects, programs, activities:** We recognize that this year it is absolutely vital that *all* children have access to summer learning experiences. The Children's Room staff has done a heroic job of extending their reach throughout the Town to engage as many children as possible with reading logs and supplies for craft projects and STEM activities. In addition to the 150 kids who picked up "kits" at the library, 240 have been distributed at summer meal sites and a multitude of virtual activities have extended the experience for those families who have Internet access. We now have a fabulous telescope purchased by the Friends of the Library which is available for loan, just in time to catch some meteor showers. I have been in conversation with Vermont Humanities Council on strategies to present the 1<sup>st</sup> Wednesday lecture series beginning this fall. We will probably begin with virtual events and move to in person presentations if public health recommendations allow.

**Community Collaboration:** BAPC provided herbs and planting kits for us to distribute and we also have Growing Resilience lawn signs for distribution. We have hosted some pop-up events for the census effort. We continue to collect phones for Turning Point. Plans for the Work Today program are moving forward. I participated in the regional COVID recovery virtual meeting and have been meeting with a group of people working on evolving Gallery Walk. Most of the pods on the pea plants along the back path have been eaten by squirrels, thus diminishing the library's peas of mind.

**Website project:** Content is with our web developers and we expect to see a mock up of our site soon. Staff and some public will test out the new site and staff will be trained to maintain and update the site.


**Personnel:** Our Interlibrary Loan clerk has retired after almost 20 years at BML. We are recruiting from within our current staff to fill the position.

**SUBJ: JULY 2020 MONTHLY REPORT**

**Summary of Major Activities/Work Projects:**

Officers responded to 891 calls for service/incidents and made 62 arrests resulting in 91 criminal charges. Included in these calls for service were 11 overdoses with 0 resulting in death. This does not mean there were only 11 overdoses in Brattleboro for this period. It merely means that these are the numbers that were responded to by police.

36 vehicle operation citations were issued along with 297 warnings. Officers spent approximately 233 hours on foot patrol in the downtown area as well as other neighborhoods and parks in Town.

**Special Meetings/Communications/Events:**

Officer's and staff continue to make numerous appearances throughout the community and communicate by electronic means to meet and discuss the concerns of the citizens. The topics included excessive force, personal safety, crime trends, homelessness and internet safety. The Brattleboro Police Department continues to make strides in educating and informing the citizens of our activity and to solicit their feedback on how we can improve our services.

**Budget Concerns/Impacts:**

Monitoring the FY 2021 budget.

**Staffing:**

Officer Chad Emery resigned leaving the department with 4 openings. A successful background check has been completed on an applicant and they will be reporting to the BPD on 17 August 2020. The 110<sup>th</sup> Basic Class at the Vermont Police Academy begins 31 August 2020. We are advertising locally and regionally to solicit applicants. College job fairs throughout New England and New York are currently suspended for health safety reasons has made our recruiting efforts not as successful as we would like. We are staying in virtual contact with many career counselors.

## COVID-19

As the Town of Brattleboro responds to COVID-19, the men and women of the Brattleboro Police Department remain steadfast in our commitment to maintain public safety, uphold the law and safeguard the well-being of our community. Our department is working closely with other law enforcement agencies, Dept. of Public Safety, and the State's Attorney Office to help reduce the spread of COVID-19.


