

COVID-19

During this month, Public Works has continued to fight the spread of COVID-19. We have instructed staff to perform all essential tasks while working as separately as possible. As we watch the number of new cases in Vermont plateau a bit, we're confident knowing that we're doing our part to stop the spread and lessen the curve.

Highway Division

This month highway crews began a drainage project on Bonnyvale Road using a "Better Back Roads" grant. Work on the retaining wall at 431 South Main St began in cooperation with Dave Manning and is nearly complete, just awaiting delivery of the stairs and fencing to finish the project. Storm drains on Clark Avenue, Main Street, Walnut Street and Harris Place were repaired. Winter road sand was hauled into the pit. The Jersey Barriers near Duo Restaurant were moved to the area near Amy's Bakery on Main ST and preparations for the fall paving project have begun.

In addition, the crew performed routine seasonal operations such as brush removal and roadside mowing. The crew also tended to the gravel roads, grading, raking, and applying calcium chloride.

Maintenance Division

As always, the Maintenance Division's focus is keeping the fleet fully operational and safe through-out our daily operations. Maintenance Staff has been assisting the Fire Department with some general maintenance of some of their vehicles. This month, in addition to general maintenance of the fleet, the staff has been mowing the lawn at the Fairground Rd facility and working on general building/grounds maintenance.

Distribution & Storage

Utilities crews have been doing a lot of work to prepare for the installation of the Pleasant Valley Waste Line project on Pipeline Road. Daniels Construction has installed the Pipeline Road culvert as part of this project.

In addition to the above operations, the crew has been doing routine summer work such as painting and mowing around hydrants and right-of-ways.

Water Treatment

Water Treatment staff have been working on watershed maintenance and repairs to Pipeline Road. Staff tests the water daily and are under contract to operate the Welcome Center and the Algiers water system. They continue to do all the daily maintenance of the all the water facilities and patrol the watershed. Staff has been maintaining required certification requirements by attending courses and classes on water treatment.

Wastewater Treatment

Wastewater Treatment staff continues to perform routine Plant and pump station operations. They continue to complete all statutory testing as required by our licensure by both State and Federal agencies. The Plant continues to operate in compliance with all permitting requirements.

The Sludge Storage Tank Cover bid was awarded to Neagly & Chase Construction Company of South Burlington, VT. We are awaiting scheduling with them.

Current Vacancies/Postings:

Firefighter vacancy; with written exam & oral board on, September 10. Diana Wahle is joining the oral board panel as our public participant. There are currently 6 candidates scheduled for the written exam, if they are successful on the written, score of 70% or higher, they will proceed to the oral board interview. The final stage in the recruitment process for Fire will be a recommendation from the Oral Board Panel of final candidates to proceed to Chief's interview.

BCJC: Re-Entry Program Coordinator was posted on, August 28th and accepting applications until September 11th; with applicant review the week of September 14th.

Human Resources has implemented the Human Resources Information System within KRONOS. Employee PERFORMANCE REVIEW training will be offered during the month of September for all Town Department Supervisors; we will utilize the cloud-based evaluation system for all employees by October 2020.

The Town's Safety & Wellness Committee held their monthly meeting on, August 17, 2020, via GTM.

Town-Wide Training calendar is in development these are the confirmed monthly training courses to date:

July: Bloodborne Pathogens – will be held annually for all Town staff with BFD.

August: Fire Extinguisher – BFD recorded training sessions and are offering live training; dates to follow for late September.

September: Fire Drills (Emergency Action Plans) with BFD in all Town Bldgs. The Town's Safety & Wellness Committee members and their alternates have been assigned as their dept./bldg reps. They will be trained during the month of September by Fire Lt. Paul Sherburne. Fire Drills (Evacuation Plan) will begin during the month of October and quarterly thereafter.

Summary of Major Activities/Work Projects:

- 1. General COVID-19 Operations** – Due to the COVID-19 pandemic, beginning March 26 all of our staff began working remotely. One staff member had been going into the office when the mail is available to process document requests, dog licenses and land recording. We have still been available to the public by phone and email to answer any questions and help in every possible way. We continue to process voter registrations online, and are catching up on many data entry and cemetery mapping and indexing projects. Our team is staying busy and being as creative as we can to continue to serve the public. Along with the rest of the Town offices, we began our Phase-I soft opening to the public on May 4, in accordance with the procedure put out by the Town Manager's office. At least one staff member has been in the office daily from 8:30am to 5pm, with appropriate breaks. With the upcoming elections, we have been functioning at full capacity in the office, as needed.
- 2. Representative Town Meeting** – Due to COVID-19, RTM was canceled by the Selectboard and has been re-warned for September 12. Currently, District 1 still has nine open seats, District 2 has one open seat, and District 3 has two open seats. District caucuses will be held on September 2, and a technology pre-meeting will be held on September 5.
- 3. November Generals** – Preparation for the General election is well under way. Ballots will be mailed to all active registered voters by the Secretary of State's office in mid-September, and we anticipate they will begin being returned to us for processing shortly thereafter. The BCA has laid out a plan for a social distance floorplan at the American Legion. All voters are encouraged to return their ballots using the drop box in the Municipal Center parking lot, or bring them directly to the polls on November 3.
- 4. Board of Civil Authority** – The Board met on July 13 to open two Property Tax Assessment Appeal Hearings, and continued those hearings on July 22. Decisions were made on August 5, and decision letters were mailed out on August 6. The Board will meet again in October for a pre-election meeting.
- 5. Cemetery Committee** – The Cemetery Committee on August 21 for their Organizational Meeting. The committee will meet again on October 3.
- 6. Board of Abatements** - The Board will meet again in October to hear abatement requests. The date and time for that meeting has not yet been set.
- 7. Liquor Licenses** – As of July 1, 2019, we are now processing and approving 3rd class liquor licenses locally along with the 1st and 2nd class license renewals before sending them to DLC for final approval. Additionally, Brattleboro currently has three businesses that hold seasonal 3rd class licenses, and we will be seeing their applications for approval in September or October, in addition to in February.
- 8. Vitals and Land Records** – we are processing these as we are able through mail, email and

online payments. We continue to encourage the public to request documents through email, mail, and fax.

9. As time allows, work continues on computerizing cemetery records, digitizing land records and other older town records.

10. Day to day operations continue to operate smoothly.

Summary of Major Activities/Projects/Communications

- BFD continues to take everyday precautions as it pertains to COVID. Though most restrictions have been lifted, masks, social distancing and hygiene continue to be stressed.
- I have begun working with BMH on plans as we moved into flu season and how COVID will affect the flu virus and increase the numbers of people getting sick.
- The Town of Brattleboro received 3,300 (approximately 25% of our population) cloth face covers from the State to distribute to citizens. Many have gone out to citizens including walk ins at the fire stations and a couple of “give aways” the firefighters held on Main St. Others have gone to local groups/businesses such as many of the schools, Groundworks, Aids Project, BMH and Town Departments. We have approximately 300 left for distribution.
- The summer food program for local school children came to an end on August 21st. Since mid-March there were 161,627 meals distributed through 5 towns. I am very proud to be able to say BFD staff played a role in this important program, helping to unload delivery trucks and making the stations available for the daily meal distribution.
- With the different “teaching deliveries” being offered as school reopens, the Academy School will continue to use Station 2 as a lunch distribution point 2 days a week.
- Two staff members are enrolled in a “Pumper Apparatus Driver Operator” (PADO) class being put on by the VT Fire Academy. The class, meeting 2 – 3 times a week, spans out over 3 months and is being held in Putney.
- Platoon #1 installed a prop on one of the mezzanines at Central Station to train on rapid intervention skills and self-rescue techniques.
- All personnel are training on the new 2020 EMS Protocols
- All shifts trained with Rescue Inc. in down firefighter CPR techniques. The shifts get together monthly with Rescue Inc shifts, alternating on the agency that picks a topic and teaches.
- FF Baldwin from Platoon #1 has created a BFD hiring, testing, recruitment presentation to show at different gatherings/meetings in hopes of spreading the word about BFD and increasing interest and the application numbers during a hiring process.

- We have purchased a video camera with intentions of videoing short fire prevention clips and safety messages to post on social media and send to the schools during COVID while we can't do in person visits.
- We continue to work on an ongoing boiler issue at Central Station. One of the two boilers installed has been quitting off and on for a little over a year. Gassett Energy has been working with the boiler rep and manufacturer and it appears a solution is in sight.
- On August 14 we held written and oral board testing for 3 candidates to fill a vacancy within BFD. One of the candidates failed the written test and was eliminated, the other 2 participated in the oral board but were not recommended by the Board for the position. We have since gone back out with a vacancy advertising, have received 7 applications and invited 6 to test. Testing begins on September 10th.

Upcoming Events

- October 14 – BFD has contracted with VT Technical College to provide staff with a 5-hour Conflict Management class to be held at BFD.

Notable Incidents

- August 4, 2020 –Responded to multiple tree and wires emergencies caused by the remnants of a tropical storm.
- August 11, 2020 – Responded to several reports of explosions in the Elliot St, Frost St and Williams St area as well as one in Mt Home Park. What is believed to be large or homemade fireworks causing the reports is under investigation by BPD.
- August 26, 2020 –Mutual aid response to Chesterfield for a large brush fire on Horseshoe Rd.

Staff news


- Two staff members are out on long term, off the job injuries. One has a severely sprained ankle and some ligament damage and will be out for approximately 3 months. The other ruptured his Achilles tendon, has undergone surgery and will be out for approximately 6 months. This coupled with an existing vacancy and vacations has put a serious shortage on staffing.

Budget

- Due to very high water & sewer bills we began working with the Utilities Division and the engineer of the building project and found that the water meter was oversized causing some expensive base charges. This past week the Utilities Division installed a new 2" meter, down from a project size of 3". This will bring our base charge on the water from \$536.83 to \$268.41 and the sewer from \$720.67 to \$360.33 for a total saving of \$628.76 per quarter or a little over \$2,500 a year.

Subject: Finance Department Activity Report – August 2020
Date: September 4, 2020

Summary of Major Activities and Work Projects:

1. The Red Clover Commons project has been issued a Grant Agreement; acceptance of the Grant will go before the Selectboard on October 6, 2020.
2. Groundworks' is still waiting on a grant award from Vermont Community Development.
3. A new Vermont Community Development application is in process for 47 Flat Street to be renovated into affordable housing units.
4. Tax bills have been mailed with the 1st due date September 15, 2020. Tax collections are \$33,000 better than this time last year. The State is still processing 2019 tax returns and homestead declarations resulting in some taxpayers requiring a revised tax bill.
5. The Treasurer's office is preparing for tax sales.
6. Final entries have been made for the FY2020 financials; auditors will be on-site the week of September 28th to perform field work. Year-end work to complete the FY2020 financials is on-going.
7. An application has been submitted to FEMA for initial emergency supplies in response to the Covid 19 pandemic. An application for additional actual and anticipated Covid-19 expenses will be submitted to the State of Vermont 9/4/20.

Summary of Major Activities/Work Projects:

Skatepark Project:

Parker Construction with DMI as one of their sub-contractors are wrapping up the Skatepark Project. Everything progressed nicely throughout the project.

Status Update:

1. Upper Plaza quarter pipe - all rebar has been installed, all formwork installed, and the shotcrete has been installed and finished.
2. Lower 3' x 14' ledge has been formed up, metal work installed, all rebar installed, concrete poured and finished.
3. A-frame feature - all rebar installed, all metal work installed, A-frame rail installed, A-frame is poured and finished.
4. Quarter pipe at the bottom of the park - all rebar installed, formwork all completed, concrete sprayed/poured and finished.
5. Bowl/Decks around the bowl - completely shaped, all rebar installed, all formwork installed, concrete shot / poured and finished.
6. Upper Plaza/Stairs in Upper Plaza - all rebar and formwork installed, concrete sprayed/poured and finished.
7. C-Channel - the metal has been installed for the stairs, primed, and painted. The rebar has been installed and the concrete has been sprayed/poured and finished. Additionally, the handrail for the stairs have been fabricated and installed.

8. The extra bonus pocket feature that was donated by Parker Construction has been shaped & formed, the rebar has been installed and the concrete has been poured / shot and troweled.

All concrete was completed on Friday August 29TH.

The remainder of the earthwork, final grading, and bioretention pond began the week of August 31ST

The concrete needs to cure until late September. Then Parker Construction will return in late September to install all caulking and apply sealer to the entire park, to complete the project.

The Recreation and Parks Department along with the BASIC Committee is planning for a ribbon cutting event to be held on Saturday Oct. 3RD, more information regarding the event will be forth coming.

Gibson Aiken Center Gymnasium Floor:

September 8 – 10 the Gymnasium Floor at the Gibson Aiken Center will be refinished with polyurethane. The vendor Myles Danaher will work with the Maintenance Staff to do the work. This year 3 sets of Pickleball Lines will be added to the court before applying the polyurethane.

COVID-19 Programs and Facilities:

The Living Memorial Park Pool closed for the season on Sunday August 16TH. We had over 4,500 visitors that utilized the pool over the course of the summer.

All our summer programs (Day Camp, Gymnastics Camp and Tennis Camp) wrapped up on Friday August 21ST. For the 9 weeks of Day Camps we had 342 participants, for the 9 weeks of Gymnastics Camp we had 205 participants, and we had 11 participants for 1 week of Tennis Camp.

The Gibson Aiken Center remains closed to the public. However, on-site visits are acceptable if the individual complies with the following Town requirements.

- 1) No one may visit the Gibson Aiken Center if they are experiencing any symptoms of respiratory distress (fever, cough, shortness of breath).
- 2) Only 1 visitor will be allowed in any office at any given time.
- 3) Visitors who do not make an appointment in advance may have to wait outside the building until it is their turn to enter.
- 4) During the visit, the 1 employee and 1 visitor will always wear masks, wear

gloves, or use hand sanitizer and abide by social distancing best practices such as standing no closer than 6 feet apart.

The Brattleboro Senior Center opened for indoor programming Monday July 20TH. Patrons are required to call in and reserve a time slot for each program, no more than 20 patrons are allowed in the at any given time, we ask that all patron social distance and wear masks.

Brattleboro Senior Meals continues to serve over 140 Meals on Wheels Daily.

Status of facilities:

- The Fred H. Harris Tennis/Pickleball Courts at Living Memorial Park are open.
- The Rotary Disc Golf Course at Living Memorial Park remains open.
- The Men's League started their games on Thursday July 9TH. The league has implemented several safety measures to comply with COVID 19 re-start play guidelines. The Women's League has chosen not to play this season.
- The Basketball Hoops at Living Memorial and Crowell Lot were put back up on Friday September 4, 2020.
- The Dog Park at Living Memorial Park is open.
- The Living Memorial Park Pool opened for the season on Saturday June 20TH.
- All (5) Playgrounds are open with COVID 19 Signage/Guidelines on
- Restrooms at Living Memorial Park and West River Park Ball Fields will be opening on Thursday July 9TH and will be cleaned and disinfected regularly throughout the day.

We continue to encourage everyone to enjoy our facilities and green spaces while following the above guidelines and the following:

- Keep Social Distancing (everyone wears masks + stays at least 6-feet apart whenever possible).
- Organized contact sports/games with spectators are allowed at this time providing COVID 19 re-start play guidelines are being followed.
- Please use the "Arrive, Play and Leave" approach to using these facilities.
- No gatherings of more than 150 people.

We continue to take reservation for Park Rentals providing groups can socially distance and keep their group size to no more than 150. Kiwanis Shelter rentals are being capped at 50 due to the limited sq. footage available at the facility.

Staffing:

The Assistant Director, Administrative Assistant, and the Program Coordinator are back working in the Office and in the field running camps/programs.

The Parks employees are working their regular schedule. Staff is following all health and safety protocols recommended by the Governor for staff working in groups.

Staff is working on plans as to how we can safely run our fall youth sports programs (field hockey and soccer) and ways to safely open the Nelson Withington Skating Facility.

Beginning the week of Sept 14TH, the Brattleboro Recreation & Parks Department and Brooks Memorial Library will join forces to offer "Gibson Aiken Center Rec. Camp" Monday – Friday from 8:00 am – 3:00 pm. The Activities will include: Morning and Afternoon Snack, Morning Group Activity, Arts & Crafts, Sports & Games, Homework Time, Library & Book Talks, Skits & Music and Outdoor Time.

Participants will be asked to bring their own technology each day, upon request a limited number of laptops and iPads will be available for use while attending camp. This program will be run by the regularly scheduled staff from both the Recreation and Parks Department and Brooks Memorial Library. The additional staff required to run this program will be local High School & College students that are learning remotely and available to share their knowledge with those that are younger.

This program will be limited to 20 participants and will be on a first come first serve basis to Brattleboro Residents. Non-Residents may enroll as space allows. The per day cost for this program will be \$25.00 per day for Brattleboro Residents and \$30.00 a day for Non-Residents. The minimum to run this program each day is 10. Life in the Time of COVID: Patrons continue to be both cautious and grateful. Many are still reluctant to come into the library and they thank us for providing curbside service. Still others, are so happy to be allowed in that they are moved to tears. We look forward to the day when we can restore hours and services to fully serve the community, but staff also has considerable anxiety about the dangers of exposure to the virus.

Town Interdepartmental Collaboration: I was a poll worker with several of my Town colleagues during the recent primary, and have met with the Town Clerk to strategize ways that the Library can support voter registration. We set up a table outdoors on several Saturday afternoons to facilitate registration and will expand our efforts to indoors whenever the library is open. The library is delighted to be included by Recreation and Parks in their initiative for a day camp. The Children's Room will provide daily programs for participants and we will support homework help at the GA center. DPW installed our spiffy new bike tool bar in front of the library, which was purchased by BCAT and the Friends of Brooks Memorial Library. We are happy to be the pick-up spot for RTM booklets and to offer wi-fi, tech support and devices to Town Meeting representatives.

Buildings and Grounds: We have new carpet on the mezzanine, but the big story is the transformation the Work Today folks have made on our spaces, both indoor and out. They have washed windows and removed weeds from the pavement areas along Main St. and along the edges of the parking lot. Years of adhesive residue throughout the building is gradually disappearing through their work on rainy days. The railing along the back walkway is absolutely gorgeous, thanks to lots of effort and several coats of paint. This was work that badly needed to be done, but was not within the budget nor staff capacity. WT allowed for the opportunity to accomplish long overdue tasks and it has paid off dazzlingly! (see photo below.) My heart soars every morning when I come to work and see the improvements. We are moving on to painting the railings leading down from the Municipal Center and the fence in front of the garden. Dick DeGray has consulted on possible landscaping projects they could work on in the future.

Projects, programs, activities: The Children's Room is working on ways to support families who are homeschooling or participating in hybrid schooling. Adult staff is expanding their consulting on reference and tech support via phone, email and in-person and we are looking at new ways of serving the community at home. I have been in conspiring with Brattleboro Literary Festival organizers on various virtual programs.

Community Collaboration: BAPC herb planting kits continue to be popular. The peas from our walkway have been harvested and dried for use as seeds, so our hope for peas in the future persist.

Generosity: We received a \$1,000 donation for Large Print materials from a fan of mystery novels. This will enable us to give a needed infusion to that part of the collection.


Professional activities: I have benefitted from many helpful supportive meetings with library colleagues in Vermont as we grapple with the procedural and personnel issues associated with reopening our facilities. I have resumed my participation in the Vermont Authors Project in the hope of promoting authors' programs virtually.

Trustee activities: Jane Southworth has been working on preparing drafts to update our policies. Jennifer Rowe has transferred our system over to Quickbooks online.

Website project: We have a preliminary version of our new site and selected staff and Trustees have been given access to provide feedback.

Personnel: We are delighted that Jennifer Clary is our new interlibrary loan clerk. She has transferred from her position as circulation clerk in the Children's Room.

Circulation: We are gradually increasing our usage numbers: We circulated 6419 items this August, which is slightly more than 48% of last August's total of 12924 items.

Summary of Major Activities/Work Projects:

- **Planning Activities and Projects**

- Worked with DPW Engineer Tech Josh Carnes on creating a traffic data map using ArcGIS Pro than exported data to ArcGIS online to create a publicly available map. Demo is process.
- Continued work from July on language for an Interpretive Sign that will be installed on the new Hinsdale Bridge.
- Provided E911 Support for 47 Flat Street project.
- Aided a Planning Commission subcommittee on the formation of norms to be used make meetings more inclusive and welcoming.
- Conducted research to find examples of housing action plans/housing need assessments to help write a grant for the 2021 Municipal Planning Grant. Staff proposes to use funds to hire a consultant to write a Housing Action Plan centered around equity and to identify barriers and solutions to create opportunities for more housing options or all.
- Wrote GISTD for approval from Town officials to be able to apply for the 2021 MPG.
- Intakes permits submitted to department during the month of August. Provided development review when needed/requested.
- Prepared Interim Zoning Bylaw in response to housing needs.
- Assisted with Representative Town Meeting planning
- Helped restart the the Agricultural Advisory Committee
- Expanded the Hazard Mitigation Committee as we get gear up for a rewrite by the end of 2019.

- **Administrative Officer/Zoning Report**

- We issued 11 permits in August as compared to 23 in August of 2019; for the year. Since the start of year, we have issued around 100 permits as compared to around 149 at the same point last year. The absence of sign applications represents most of the difference.
- Continued to work on minor violations as well as on going enforcement issues at 33 Oak, 6 Reynolds, and 48-50 Central, with tickets totaling \$900 issued during the month.
- Did training on 2-dimensional floodplain modeling regulatory issues, 2020 Residential Energy Standards, CRS watershed management 2020 manual changes.
- Following changes to the CRS prerequisites that will require minor zoning amendments.
- Site plan inspections focused on erosion control.
- Reading in preparation for HMP re-write.
- Updated forms for updated permit specialist, RBES standards, renewable & energy efficiency programs
- Safety and Wellness committee
- Numerous requests for zoning compliance; many inquiries for Summit Circle.

- **Sustainability**

- Met with the following groups or their members of their leadership: Brattleboro Coalition for Active Transport, Edible Brattleboro, 350Brattleboro, Brattleboro Common Sense, Strolling of the Heifers, Retreat Farm, VT Food Bank, Food Connects, WSESU school board, Brattleboro Savings & Loan, Friends of the West River Trail, Monadnock Regional Rail Trail Collaborative, Rich Earth Institute, Groundworks Collaborative, Building a Positive Community, Vermont Council on Rural Development, and the Vermont Land Trust.
- Performed preparatory work and supervisor training for ECOAmericorps service member, Kevin O'Brien, who will start 9/14/20.
- Energy: explored new opportunities to eliminate coal in Brattleboro with consideration of new WRC-based resources, further researched the potential to invest in local lands to sequester/offset the Town's carbon footprint. Planned projects (lighting and thermostat auditing) for the Americorps service member to pursue during winter months. Continue to collect energy usage data and meet internally to streamline and standardize reporting of such data. Created a Facebook page for the Energy Committee to perform educational public outreach. Started content and outreach planning with Millicent Cooley, member of the Energy Committee. Met with Josh Carnes, engineer at DPW, and ruled-out the possibility of utilizing the Town's reservoir as a stored-hydro facility, as well as the possibility of capturing energy from the Town's wastewater flows.
- Trails: organized planning meetings for possible National Park Service support to fund an inventory assessment for a portion of the Hogle Trail. Worked with NPS, VCRD, and many others to gain traction in negotiating with the railroads on a possible rail-trail between Whetstone Station and the confluence of the West and Connecticut Rivers. Scoping work began this month at Winston-Prouty/Delta campuses with support of this office and NPS funding, with the goal of improving an existing class 4 logging road to be a bikeable path across the two campuses, along with other improvements.
- Food: established a new social media picture campaign/contest with Retreat Farm for gardeners to share about their gardens, distributed more yard signs to community gardeners, facilitated submission of a grant for Edible Brattleboro to hold canning, pickling, and other preservation workshops for the community, coordinated with DBA and Edible Brattleboro to establish a mechanism for donated produce to be given to the Everyone Eats! program, helped re-start the Town's Agricultural Advisory committee. Organized an initial planning meeting to establish a seed and tool library in Brattleboro. Participated in brainstorming for local food economy including ideas such as: establishing a local currency, new "pay-what-you-can" restaurant models, developing community enterprises/infrastructure (such as a grain mill/bakey, or meat-processing plant), and finding new ways to connect Main St. and restaurants with the charitable food economy and community-scale production from gardens and gleaning.
- Outdoor classroom/meeting space coordination: started organizing conversations to better enable the community to more easily utilize "the commons" for schools and public meetings.
- Explored "Eco-Municipality" and "Transition Town" models for the Town to consider pursuing as pathways, frameworks, and processes for comprehensive sustainability planning.
- Volunteered at the polls for the primary election.
- Took a vacation!

- Committees/commissions: met with the Energy, Conservation, and Tree committees/commissions.
- Trainings: UVM - carbon markets & wood, Transition Town regenerative leadership series, and the DEI - whiteness at work series.



SUBJ: AUGUST 2020 MONTHLY REPORT

Summary of Major Activities/Work Projects:

Officers responded to 902 calls for service/incidents and made 47 arrests resulting in 68 criminal charges. Included in these calls for service were 8 overdoses with 2 resulting in death. This does not mean there were only 8 overdoses in Brattleboro for this period. It merely means that these are the numbers that were responded to by police.

17 vehicle operation citations were issued along with 321 warnings. Officers spent approximately 244 hours on foot patrol in the downtown area as well as other neighborhoods and parks in Town.

Special Meetings/Communications/Events:

Officer's and staff continue to make numerous appearances throughout the community and communicate by electronic means to meet and discuss citizen concerns. The topics included excessive force, personal safety, crime trends, homelessness and internet safety. The Brattleboro Police Department continues to make strides in educating and informing the citizens of our activity and to solicit their feedback on how we can improve our services.

Budget Concerns/Impacts:

Monitoring the FY 2021 budget.

Staffing:

The Department currently has 3 openings. A successful background check has been completed on our newest hire, Jared Matos. Jared is currently attending the 110th Basic Class at the Vermont Police Academy which started 31 August 2020. We are advertising locally and regionally to solicit applicants. College job fairs throughout New England and New York are currently suspended for safety reasons due to the COVID-19 pandemic which has made our recruiting efforts not as successful as we would like. We are exploring virtual options for recruitment.

COVID-19

As the Town of Brattleboro responds to COVID-19, the men and women of the Brattleboro Police Department remain steadfast in our commitment to maintain public safety, uphold the law and safeguard the well-being of our community. Our department is working closely with other law enforcement agencies, Dept. of Public Safety, and the State's Attorney Office to help reduce the spread of COVID-19.

We are in normal operations with an emphasis on safety. We are following the directives and recommendations set for by local, state and federal subject matter experts.

All patrol shifts remain fully staffed as there has been no change to our schedule.


