COVID-19

During this month, Public Works has continued to fight the spread of COVID-19. We have instructed staff to perform all essential tasks while working as separately as possible, staff who are able have been working remotely. As we watch the number of new cases in Vermont plateau a bit, we're confident knowing that we're doing our part to stop the spread and lessen the curve.

Highway Division

The Highway crew has completed the spring line striping and has begun the seasonal roadside mowing. The RFB has been installed at the crosswalk at Putney Road and North Street. The speed humps were installed on Guilford Street this month. Crews assisted with the placement of the jersey barricades on Main Street, Elliot Street and in the High-Grove Parking lot to allow businesses more outside space for customers while the Governor has limited occupancy in stores and restaurants. Staff has also been working on cleaning and repairing catch basins around town. At the end of the month, staff resumed sweeping parking lots.

This month, the crew performed routine seasonal operations such as line striping, patching potholes, sign repair, street sweeping and brush removal.

Maintenance Division

As always, the Maintenance Division's focus is keeping the fleet fully operational and safe through-out our daily operations. Maintenance Staff has been assisting the Fire Department with some general maintenance of some of their vehicles. Staff also repaired some railing at the Brooks Memorial Library. This month, in addition to general maintenance of the fleet, the staff has been mowing the lawn at the Fairground Rd facility and working on general building maintenance, including pressure washing the exterior walls and doors.

Distribution & Storage

The Chestnut Hill Reservoir retaining wall was completed this month. Skip Fletcher returned to oversee this project and the wall has been installed and all that remains of the project is some prep work and paving. Due to the COVID-19 pandemic, this division has continued to limit contact with the public which has hindered meter reading, 'call backs' for meter issues and meter replacement. Staff worked on inventory and has also been performing routine operations such as sewer maintenance, hydrant maintenance, vehicle maintenance, and various service calls.

In addition to the above operations, the crew has been doing routine summer work such as painting and mowing around hydrants.

Water Treatment

Water Treatment staff have been working on watershed maintenance and repairs to Pipeline Road. Staff tests the water daily and are under contract to operate the Welcome Center and the Algiers water system. They continue to do all the daily maintenance of the all the water facilities and patrol the watershed. Staff has been maintaining required certification requirements by attending courses and classes on water treatment.

Wastewater Treatment

Wastewater Treatment staff continues to perform routine Plant and pump station operations. They continue to complete all statutory testing as required by our licensure by both State and Federal agencies. The Plant continues to operate in compliance with all permitting requirements.

The sludge dryer pilot program continues and staff continues coordinate with consultants in an effort to control odors.

Summary of Major Activities/Work Projects:

- 1. General COVID-19 Operations** – Due to the COVID-19 pandemic, beginning March 26 all of our staff began working remotely. One staff member had been going into the office when the mail is available to process document requests, dog licenses and land recording. We have still been available to the public by phone and email to answer any questions and help in every possible way. We continue to process voter registrations online, and are catching up on many data entry and cemetery mapping and indexing projects. Our team is staying busy and being as creative as we can to continue to serve the public. Along with the rest of the Town offices, we began our Phase-I soft opening to the public on May 4, in accordance with the procedure put out by the Town Manager's office. At least one staff member has been in the office daily from 8:30am to 5pm, with appropriate breaks.
- 2. Representative Town Meeting** – Due to COVID-19, RTM was canceled by the Selectboard and will be re-warned when appropriate. Currently, District 1 still has eight open seats, and District 3 has one open seat due to the resignation of the incoming Selectboard member.
- 3. WSESD Annual Meeting** – Due to COVID-19, the March 17 WSESD Annual Meeting was postponed, and was held by ballot instead of a floor vote on June 30. A total of 957 Brattleboro voters (10% of our voter checklist) participated in this vote, with 736 (77%) of those voting by absentee ballot.
- 4. August Primaries and November Generals** – Discussions are continuing around how to hold the upcoming elections. A significant number of absentee ballot requests have been coming in, and ballots for the Primaries have already been mailed to voters. The BCA continues our planning for social distance layouts for the August election at the American Legion. All voters are encouraged to update their registration and mailing addresses, and request ballots by mail.
- 5. Board of Civil Authority** – The Board will be meeting on July 13 to open Property Tax Assessment Appeal Hearings for any appeals that are filed by the July 3 deadline, and again on later in the month for a pre-election meeting.
- 6. Board of Abatements** - The Board will be meeting on July 13 to hear all abatement requests that have come in. Currently there are five requests.
- 7. Dog Licenses** – 2020 dog licenses continue to be issued. Due to the COVID-19 pandemic, late fees have been waived until further notice. While the late fee after the April 1 deadline has been waived, dogs are still required to be licensed per statute. We estimate that we have issued 1004 2020 licenses, and there remain approximately 230 unlicensed dogs in town for 2020. Licensing has been slower than normal due to the pandemic.
- 8. Brattleboro Cemetery Committee** – The committee's April meeting to continue the discussion on green burials will be rescheduled for a later date, due to the COVID-19 pandemic. An organizational meeting will be scheduled for sometime in July. Cemetery records are being

computerized.

9. **Vitals and Land Records** – we are processing these as we are able through mail, email and online payments. We continue to encourage the public to request documents through email, mail, and fax.
10. As time allows, work continues on computerizing cemetery records, digitizing land records and other older town records.
11. Day to day operations continue to operate smoothly.

Summary of Major Activities/Work Projects:

In the Assessment Office during the month of June the staff's time was devoted to the preparation and attendance of Grievance Hearings held from June 9-16. The Assistant Assessor and Assessor Technician attended the grievance hearings along with the Town Assessor. There were 31 hearings which were held on a remote access platform, GoToMeeting. The Listers deliberated on their decision June 16th and result of grievance letters were sent out June 18th. The Listers met with the Assessors to review the Grievance Process on the same GoToMeeting format at their annual Lister meeting.

Business Personal Property Asset Reports continue to be processed as the deadline was extended into July.

Final preparations were made, and tests run on the printing of the Grand List to be completed the first week of July.

Staff continues to work remotely part-time sharing office hours at the Town Office. Daily AM GoToMeeting staff meetings also continue.

Second reminder letters were sent to Farm Stabilization participants.

Communications

Normal operations have resumed at the Brattleboro Fire Department with some COVID – 19 precautions still in place.

- All “normal” daily functions such as inspections, fire prevention, school visits, and outside training classes have resumed.
- Our buildings are open to the public, face covers required.
- Conference calls continue every Thursday with VT Emergency Management and include VT Department of Health, VT EMS, Office of the Medical Examiner, Dept of Public Safety, and others.
- School Meals Program continues will continue distribution from both stations through August.
- Each Wednesday in July there are more state food PODs happening at BUHS.
- With the resumption of life safety inspections we are nearing the completions of “Zone 1” and should be starting in “Zone 2” in the fall.
- July 15 - BFD staff will be attending a training session presented by BPD Lt Carl Warner on de-escalation tactics
- Included this month are the 6 month statistics for emergency responses and a break out of the overdose information. A statistic that caught our attention; of the 1293 response in 2020, 315 or 25.76% were overlapping calls. In other words, we had 2 or more calls going at once 315 times.

Staff

- Staff “health screenings” twice a shift, will continue
- Face coverings continue to be worn by staff in public settings and as needed.
- The Office Manager is back on the 5 days/week in the office (8a-4p)
- Staff continues to make “grocery store and pharmacy runs” at the request of a few high-risk citizens

Notable Incidents

- June 19 – Mutual aid with an Engine to Keene for a building fire.

Staff news

- FF Alex Morin, a 4 year member of the career staff, has submitted his resignation. Alex has accepted a firefighter position in Falmouth, ME, his last day with BFD is July 26.

BFD has answered 1293 calls for assistance in 2020 as of this date
227 responses in June
49 overdose calls in 2020 / 7 in June / 1 fatality in June

DURING SUMMER HEAT

- **Slow down:** Reduce, eliminate or reschedule strenuous activities until the coolest time of the day. Children, seniors and anyone with health concerns should stay in the coolest available place, not necessarily indoors.
- **Dress for summer:** Wear lightweight, loose-fitting, light-colored clothing to reflect heat.
- **Eat light:** Choose easy-to-digest foods such as fruit or salads. If you pack food, put it in a cooler or carry an ice pack. Meats and dairy products can spoil quickly in hot weather.
- **Drink plenty of water (not very cold):** Focus on non-alcoholic and decaffeinated fluids. Drink water even if you don't feel thirsty. If you're on a fluid-restrictive diet or have a problem with fluid retention, consult a physician before increasing consumption of fluids.
- **Use air conditioners:** Spend time in air-conditioned locations such as malls and libraries if your home isn't air conditioned.
- **Use portable electric fans:** Fans exhaust hot air from rooms or draw in cooler air. Do not direct the flow of portable electric fans toward yourself when room temperatures are hotter than 90°F. The dry blowing air will dehydrate you faster, endangering your health.
- **Minimize direct exposure to the sun.** Sunburn reduces your body's ability to dissipate heat. Take a cool bath or shower.
- **Do not take salt tablets:** Only take salt tablets if recommended by a physician.

Summary of Major Activities/Work Projects:

Skatepark Project:

Parker Construction with DMI as one of their sub-contractors started the Skatepark Project the week of June 15TH. Currently everything has been progressing nicely. The earthwork proceeded on schedule. The coping was installed for the upper plaza quarter pipe and they started to pour the footing for the retaining wall and one of the ledges on Wednesday July 8TH.

COVID-19 Programs and Facilities:

The Living Memorial Park Pool opened on Saturday June 20TH. Attendance has been a little low, however being open has added to the quality of life of our citizen during this difficult time. We have (2) three-hour general swim sessions daily 1:00 – 4:00 PM & 5:00 – 8:00 PM with a capacity of 75 per session. Several times during each session and in between each session all the high touch areas are being disinfected. To date we have had a total of 1,042 swimmers and this includes our Day Campers that use the Pool between 11:00 AM – 12:45 PM each day.

Summer programs started the week of June 22ND. Registrations are low but are still coming in slowly. We are at about 70% capacity for all our camps.

We still have space in the following camps: Day Camp, Gymnastics Camp, Tennis Camp, Magical Earth Camp, Flag Football Camp, and Mad Science Camp.

Due to the COVID 19 restrictions the following summer camps and programs have been canceled: Baseball / Softball Camp, Basketball Camp, Soccer Camp, Lacrosse Camp, Swim Lessons, and Swim Team.

The Summer Tuesday Night “Arts in The Park” Concert series has been canceled for the summer.

The Gibson Aiken Center is closed to the public. However, on-site visits are acceptable if

the individual complies with the following Town requirements.

- 1) No one may visit the Gibson Aiken Center if they are experiencing any symptoms of respiratory distress (fever, cough, shortness of breath).
- 2) Only 1 visitor will be allowed in any office at any given time.
- 3) Visitors who do not make an appointment in advance may have to wait outside the building until it is their turn to enter.
- 4) During the visit, the 1 employee and 1 visitor will always wear masks, wear gloves, or use hand sanitizer and abide by social distancing best practices such as standing no closer than 6 feet apart.

Staff is working on plans as to how to safely open the Senior Center later in the month for indoor programming keeping in mind the health and safety of both the patrons and staff.

Brattleboro Senior Meals continues to serve over 140 Meals on Wheels Daily.

Status of facilities:

- The Fred H. Harris Tennis/Pickleball Courts at Living Memorial Park are open.
- The Rotary Disc Golf Course at Living Memorial Park remains open.
- The Men's League started their games on Thursday July 9TH. The league has implemented several safety measures to comply with COVID 19 re-start play guidelines. The Women's League has chosen not to play this season.
- Basketball courts at Living Memorial and Crowell Lot remain closed until further notice.
- The Dog Park at Living Memorial Park is open.
- The Living Memorial Park Pool opened for the season on Saturday June 20TH.
- All (5) Playgrounds opened with COVID 19 Signage/Guidelines on July 1ST.
- Restrooms at Living Memorial Park and West River Park Ball Fields will be opening on Thursday July 9TH and will be cleaned and disinfected regularly throughout the day.

We continue to encourage everyone to enjoy our facilities and green spaces while following the above guidelines and the following:

- Keep Social Distancing (everyone wears masks + stays at least 6-feet apart whenever possible).
- Organized contact sports/games with spectators are allowed at this time providing COVID 19 re-start play guidelines are being followed.
- Please use the "Arrive, Play and Leave" approach to using these facilities.
- No gatherings of more than 150 people.

Beginning the July 1, we started taking reservation for Park Rentals providing groups can social distance and keep their group size to no more than 150. Kiwanis Shelter rentals are being capped at 50 due to the limited sq. footage available at the facility.

Staffing:

The Assistant Director, Administrative Assistant, and the Program Coordinator are back working in the Office and in the field running camps/programs.

The Parks employees are working their regular schedule. Staff is following all health and safety protocols recommended by the Governor for staff working in groups. In addition, assisting with ensure the Living Memorial Park facilities, Day Camp Areas and the Swimming Pool and being cleaned and disinfected on a regular basis.

All the summer staff have been hired and started work on June 18TH (Pool Manager, Water Safety Instructors, Lifeguards, Cashiers, Pool Checkers, Seasonal Maintenance, and Summer Camp Counselors).

 - Request extension of the VCDP Tri-Park Master Plan grant and supplemental funding for additional planning work
 - Met with VTrans staff to discuss easements and improvements related to Hinsdale Bridge Project

- **Administrative Officer/Zoning Report**
 - The Development Review Board held its first online meeting. The meeting had two applications and one appeal of a zoning administrator's determination. The appeal and one of the applications were contentious with many interested parties and a need to create a detailed record for the Court as appeals are likely. The meeting proved orderly; a clear record has been produced; Board members, appellants, applicants, interested parties, and involved attorneys all seem satisfied with the proceedings. Meeting follow-up and feedback has reinforced that the meeting went well.
 - A substantial 3 residential units, one commercial unit mixed use building was approved by the Board for 55 Black Mountain Road
 - A hearing for a mixed use, 15 residential unit, one floor professional services shared space building at 47 Flat will be heard by the DRB July 15.
 - Nuisance enforcements involving trash, furniture left by roadside, fowl, tag sale, and stored cars.
 - Increased volume of permit applications, twice what we received in June 2019, still 20 fewer for year to date

- **Sustainability**
 - Helped to organize multi-town energy discussion and arrange a presentation by Windowdressers to 25+ towns and regional commission representatives, with the hope of assembling a multi-town program in the future.
 - Engaged with the Energy Committee to pursue a presentation of a proposal regarding carbon offsets, as well as strategizing about outreach via social media and an updated webpage on the Town website.
 - Launched the Growing Resilience gardening campaign including creation of a website, social media team, yard signs and flyers, and numerous instances of earned media (TV, print, radio)

- Pursued discussions and efforts to strategize new ways of capturing the increased harvest from the increased gardening this year, in consultation with VT Food Bank, Food Connects, BAMA, BCAT, and others.
 - Assembled a JEDI (justice, equity, diversity, and inclusivity) working group within the food task force, to examine and improve the relationships between the land, the food grown on the land, and the history of racial oppression and displacement.
 - Made great progress on trails in general: NPS provided \$2500 in support to Winston-Prouty/Delta's efforts to scope new trails and plan an upgrade of their trail systems into a unified system. Regarding the Hogle Trail: all relevant stakeholders have been identified and contacted to engage in the planning process, with the Abenaki (via Rich Holschuh) leading the vision. Met with the Monadnock Rail Trail Collaborative and we are developing a joint presentation of inter-connecting trail efforts on either side of the Connecticut River, to be used to seek joint funding from USDA, others. Attended 2 webinars on municipal trail development.
 - Organized a working group to pursue the seed/tool library, which will have a special section for heritage seeds of the Abenaki.
 - Moved forward a new concept and effort to restart the Agricultural Advisory committee, helped identify members and articulate a slightly different charge than the committee previously held.
 - Helped arrange for the delivery and distribution of over 2000 free veggie starts to be used in gardens for public benefit, in coordination with Retreat Farm, Food Connects, Foodworks, and Northeast Hemp Commodities.
 - Organized discussions to develop an adopt-a-garden model for the community, in conjunction with AUNE, C&S Wholesalers, and Edible Brattleboro.
 - Met with Tara Davis of Oak Grove School, who has developed a plan for creating outdoor classroom/meeting space around the perimeter of the school that would also include gardens as an educational aid and seek to amplify Brattleboro's most significant monument to BIPOC leadership, the tree planted at Oak Grove School by Wangari Maathai.
 - Capitalized on a last minute opportunity to obtain an EcoAmericorps Service Member who will support the sustainability coordinator from Aug. 2020 - Aug. 2021.
 - Assisted in distributing over 400 gallons of free milk to the community alongside Strolling of the Heifers.

Departmental Monthly Activities Report for June 2020

Life in the Time of COVID: Our curbside service continues to grow and we have added a home delivery option for patrons who are unable or uncomfortable coming to the library. We have been preparing, adjusting both our physical space and our procedures, for opening to the public on a limited basis. We currently plan to open for 20-minute visits for up to 30 people, with entrance on the hour and half-hour from noon-4:30 beginning Monday, July 13th. The 20-minute time periods will limit prolonged personal exposure and allow us to clean frequently touched surfaces for 10 minutes between groups. Masks are mandatory for staff and public as is hand sanitizing upon entering.

There will be computer access in the first floor, along with copying and printing capabilities. Much of our furniture has been stored and only limited seating is available, to avoid congregating and contact with surfaces. Personal assistance will be available within social distance.

Plexiglas barriers are in place, as are hand sanitizing stations at each entrance. Directional arrows will guide patrons through the stacks. There will be no newspapers to read on site, but magazines will be available to take home, including the current issues. The toys and activity tables have been removed from the Children's Room and we have temporarily raised the age for unattended children to 11.

Projects, programs, activities: The Children's Room staff has put together an ambitious program to keep kids engaged and learning throughout the summer. This is always a high intensity time for youth services, but this year requires a complete overhaul. Usually the program is about personal or shared experience; reading, making art, attending events, conducting science experiments, observing nature, etc. This year, everything has to be virtual or material; things that can be taken home to make art and explore science, and events that can be experienced online. The staff has done a remarkable job designing and preparing hundreds and hundreds of take-away activity kits to enrich family life and learning. We have also expanded our outreach in this area to coordinate with lunch distribution around town to include kids who are not regular library users.

Community Collaboration: In addition to the outreach listed above, the BML worked with a library patron to create a Juneteenth display in a storefront on Main St., which included screening the PBS Juneteenth program on a large screen with closed captions repeatedly on Friday and Saturday. We continue to collect phones for Turning Point. There are pods on the pea plants Edible Brattleboro planted along the back path to the Library, so the library is contributing to peas on earth.

Website project: Jeanne has been collecting content from our team and MRW will be populating our new site with updated and streamlined pages!!

Promotion: Our Facebook presence continues to be active and we receive a lot of positive feedback on our weekly Constant Contact newsletter and our encounters curbside.

Summary of Major Activities and Work Projects:


1. The Red Clover Commons project has submitted award conditions, but some modifications are required. The Selectboard approved a \$100,000 loan to Red Clover Commons to help satisfy a financing shortfall.
2. Utility bills have been mailed for the final period of FY2020; the payment due date for these bills is still August 15, 2020. Tax bills will be delayed until mid-August with the 1st due date of September 15, 2020. The Town is waiting on education tax rates and numbers to set the tax rate.
3. The Windham Windsor Housing Trust Scattered Site Grant has been signed and the 1st requisition submitted and approved.
4. Groundworks' \$500,000 grant application to assist with the construction of a new facility has been submitted to VCDP. The application was considered by the VCDP board at its April 4, 2019 meeting and has awarded a \$400,000 grant for the project. Brattleboro has not yet received a draft grant agreement between the Town and VCDP for the Groundworks project. The Town has committed \$50,000 to the project as a grant from Program Income funds. An additional \$100,000 appropriation from Program Income funds was approved at the July 9, 2019 Selectboard meeting.
5. An application has been completed for the State Water Revolving Loan Fund to complete water system upgrades.

SUBJ: JUNE 2020 MONTHLY REPORT

Summary of Major Activities/Work Projects:

Officers responded to 771 calls for service/incidents and made 56 arrests resulting in 99 criminal charges. Included in these calls for service were 6 overdoses with 1 resulting in death. This does not mean there were only 6 overdoses in Brattleboro for this period. It merely means that these are the numbers that were responded to by police.

44 vehicle operation citations were issued along with 330 warnings. Officers spent approximately 253 hours on foot patrol in the downtown area as well as other neighborhoods and parks in Town.

Special Meetings/Communications/Events:

Officer's and staff continue to make numerous appearances throughout the community and communicate by electronic means to meet and discuss the concerns of the citizens. The topics included excessive force, personal safety, crime trends, homelessness and internet safety. The Brattleboro Police Department continues to make strides in educating and informing the citizens of our activity and to solicit their feedback on how we can improve our services.

Budget Concerns/Impacts:

Monitoring the FY 2021 budget.

Staffing:

The Department currently has 3 openings. A successful background check has been completed on an applicant and their start date at the BPD is scheduled for 17 August 2020. The 110th Basic Class at the Vermont Police Academy begins 31 August 2020. We are advertising locally and regionally to solicit applicants. College job fairs throughout New England and New York are currently suspended for safety reasons due to the COVID-19 pandemic which has made our recruiting efforts not as successful as we would like.

COVID-19

As the Town of Brattleboro responds to COVID-19, the men and women of the Brattleboro Police Department remain steadfast in our commitment to maintain public safety, uphold the law and safeguard the well-being of our community. Our department is working closely with other law enforcement agencies, Dept. of Public Safety, and the State's Attorney Office to help reduce the spread of COVID-19.


We have returned to normal operations with an emphasis on safety. We are in compliance with the directives and recommendations set for by local, state and federal subject matter experts.
